## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

PROJECT NAME: Special Event Permit - Kensington Social & Athletic Club - Holiday at Home

**COMMUNITY PLAN AREA:** Kensington-Talmadge

**COUNCIL DISTRICT: 9** 

**LOCATION:** Marlborough Drive

**PROJECT DESCRIPTION:** Special Event Permit for a parade and relay race event that would include animals, cars and trucks, sound amplification, the temporary use of portable restrooms, trash/recycling bins, and would occur along Marlborough Drive on May 27, 2024.

See map attached. Noise associated with the event activities and set-up/dismantling would occur from 8 AM until 12:30 PM on May 27, 2024. The relay race would occur along Marlborough Drive between Alder Drive and Bedford Drive, starting at 9 AM on May 27, 2024. The parade would occur on Marlborough Drive between Adams Avenue and Ridgeway Drive, starting at 10:30 AM on May 27, 2024. A speaker system would be used to call the race and announce the parade entries and sound amplification would occur from 9 AM until 12:30 PM. An awards ceremony would occur at 12 PM in front of Kensington Community Church on Marlborough Drive. On May 27, 2024, set-up for the race/parade event would occur from 8 AM until 8:45 AM, the race and parade would occur from 9 AM until 12 PM, and the event would be dismantled between 12 PM and 12:30 PM.

A road and parking closures would be associated with this event and would include Marlborough Drive between Adams Avenue and Palisades Drive, Cantebury Drive between Bedford Drive and Palisades Drive, Palisades Drive between Cantebury Drive and Marlborough Drive from 8:00 AM until 1 PM. Parking closure would occur on both sides of the streets listed above from 6 AM until 1 PM on May 27, 2024.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for

causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
