PUBLIC SERVICE ANNOUNCEMENT REGARDING MEETING ACCESS

Until further notice, Hearing Officer meetings will be conducted pursuant to the provisions of California Government Code section 54953(a), as amended by Assembly Bill 2249.

The Hearing Officer will be in person and the meeting will be open for in-person testimony. Additionally, we are continuing to provide alternatives to in-person attendance for participating in Hearing Officer meetings.

The public is encouraged to <u>subscribe</u> to receive meeting agendas.

In lieu of in-person attendance, members of the public may also participate and provide comment via telephone, ZOOM, using the Hearing Officer <u>webform</u>, or via U.S. Mail of written materials, as follows:

HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

<u>In Person for Agenda Items and Non-Agenda Public Comment:</u> Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

<u>Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:</u> When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

Those participating virtually may NOT cede time to others participating in person or virtually.

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the webform, indicating the comment type and item number (if relevant). Comments must be submitted the business day prior to the meeting to be distributed to the Hearing Officer and posted online with the meeting materials. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer website for further instructions.

<u>Written Materials:</u> Instead of submitting materials as an attachment to the <u>webform</u>, you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Please Note: Documents related to the Hearing Officer meeting agenda items which are distributed to the Hearing Officer prior to the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 1st Floor, San Diego, CA. 92101.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 3rd Floor, San Diego, CA. 92101. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.

ITEM 1: 702 LORING STREET - PROJECT NO. 1072445

Staff: John Norris **City Council District:** 1 **Plan Area**: Pacific Beach

Coastal Development Permit to convert an existing 664 square-foot garage into an Accessory Dwelling Unit at 702 Loring Street. The 0.159-acre site is located in the RS-1-7 zone, Coastal Overlay Zone (Appealable Area), Coastal Height Limit Overlay Zone, First Public Roadway, Parking Impact Overlay Zone, and the Transit Priority Area within the Pacific Beach Community Plan area. This project is categorically exempt from CEQA pursuant to CEQA State Guidelines, Section 15303 (New Construction or Conversion of Small Structures). Report No. HO-24-018.

ITEM 2: ESPINOSA – PROJECT NO. 688307

Staff: Karen Bucey City Council District: 1 Plan Area: La Jolla

Coastal Development Permit and Site Development Permit to construct a two-story, 13,235 square-foot dwelling unit over a basement, subterranean garage and an accessory dwelling unit. The 0.65-acre site located at 8025 Calle Del Cielo is in the La Jolla Shores Planned District – Single Family (LJSPD-SF) Base Zone, Coastal Overlay (Non-Appealable), Coastal Height Limit, Geologic Hazard (No. 26), Parking Impact, and Transit Priority Area Overlay Zones within the La Jolla Community Plan and Local Coastal Program Land Use Plan. This project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Section 15303 (New Construction). Report No. HO-24-020.

DEPARTMENT RECOMMENDATION

Approve the project.
