Rep from Whitburn's office - City wide DIF has \$750,000 set aside for Golf Course Dr construction. Needs \$4 Million based on last request. Some of \$750,000 is being used for finishing the design. Office has allocated \$217K to non-profits CPPF funds from our district. (\$25K to golden hill).

'I Love My Park Day' will be in Golden Hill this year

Evelyn Velasquez from the San Diego Airport Authority is here as a point of contact to share general updates on Terminal 1 project. First phase of parking project will open August 2024 and terminal 1 opens late summer 2025. Quiet home program is updating decibel contour mapping. Evelyn Velasquez shared that it is remapped every 5 years.

Informational Item 601: Upcoming community workshop this Friday 3/29/24 at 6PM in Golden Hill Recreation Center for the Fern & Grape intersection. Council member Whitburn, the GGHPC board members as well as transportation engineers will be available to answer community questions. The project has already began with paint markings. There are 5 proposals that traffic planning has brought forward and wants to complete all 5 including a no turn sign and a larger oversized stop sign.

Item 602: Blueprint SD is a general plan amendment for development patterns, affecting zoning and housing. It is in the initial phase. Monica requests that the board members review the public information for discussion at a later time.
