**PROJECT NAME:** As-Needed Geotechnical Consultant Services for Chollas Creek Improv 1A

**COMMUNITY PLAN AREA:** Mid-City Communities: City Heights

**COUNCIL DISTRICT:** 9

**LOCATION:** Work will occur within City right-of-way and easements along University Avenue and Oakcrest Drive.

**PROJECT DESCRIPTION:** The action proposed is for the approval of a geotechnical consultant services contract with Group Delta Consultants for the Chollas Creek Improv 1A project. The scope of the consultant services contract includes the procurement of permits, preparation of a work plan, utility clearance surveys prior to commencement of field work, boring for soil samples, backfilling and patching of boreholes, laboratory testing of soil samples, and preparation of a summary report.

**ENVIRONMENTAL DETERMINATION:** This activity is statutorily exempt from CEQA pursuant to CEQA State Guidelines, Section 15262 (Feasibility and Planning Studies).

Applications to appeal CEQA determinations made by staff to the City Council must be filed in the Office of the City Clerk within five (5) business days from the date of the posting of this Notice April 25, 2024. Appeal procedures are described in Information Bulletin 505 (<https://www.sandiego.gov/sites/default/files/dsdib505.pdf>). Appeals to the City Clerk must be filed by email or in person as follows:

The appeal filing fee must be United States Postal Service (USPS) postmarked within five (5) business days of the date the appeal is filed.

Deposit the fully completed appeal application (including grounds for appeal and supporting documentation) to the City Administration Building – Public Information Counter (Open 8:00 a.m. to 5:00 p.m. Monday through Friday excluding City-approved holidays), 1<sup>st</sup> Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00 p.m. on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer. Please include the project name on the memo line of the check/money order. This Drop-Off Box is checked daily, and payments are processed the following business day.
