**PROJECT NAME:** As-needed Consultant Services for a Feasibility Study for Spindrift Drive Beach Access Walkway

**LOCATION:** The project includes work areas on Spindrift Drive and the public walkway leading to the beach between 2000 Spindrift Drive and 1920 Spindrift Drive.

**PROJECT DESCRIPTION:** This action is for the approval of as-needed consultant services contract in support of a feasibility study of the Spindrift Drive Beach Access Walkway project. The contract includes preparation of a feasibility study and various technical and environmental tasks, including subsurface geotechnical investigations.

Appeals to the City Clerk must be filed by email or in-person as follows:
