NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: As-needed Consultant Services for a Feasibility Study for Spindrift Drive Beach Access Walkway

COMMUNITY PLAN AREA: La Jolla

LOCATION: The project includes work areas on Spindrift Drive and the public walkway leading to the beach between 2000 Spindrift Drive and 1920 Spindrift Drive.

PROJECT DESCRIPTION: This action is for the approval of as-needed consultant services contract in support of a feasibility study of the Spindrift Drive Beach Access Walkway project. The contract includes preparation of a feasibility study and various technical and environmental tasks, including subsurface geotechnical investigations.

On April 19, 2024, the City of San Diego made the above-referenced environmental determination pursuant to the California Environmental Quality Act (CEQA). Applications to appeal CEQA determinations made by staff to the City Council must be filed in the Office of the City Clerk within ten (10) business days from the date of the posting of this Notice May 3, 2024. Appeal procedures are described in Information Bulletin 505 (<https://www.sandiego.gov/sites/default/files/dsdib505.pdf>). Appeals to the City Clerk must be filed by email or in-person as follows:

You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be United States Postal Service (USPS) postmarked within 5 business days of the date the appeal is filed.

Deposit the fully completed appeal application (including grounds for appeal and supporting documentation) to the City Administration Building—Public Information Counter (Open 8:00 a.m. to 5:00 p.m. Monday through Friday excluding City-approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00 p.m. on the last day of the appeal period.
