AMENDMENT NO. 4 TO THE AGREEMENT BETWEEN CITY OF SAN DIEGO AND RELX INC. FOR SKIP TRACING SERVICES

This "Amendment No. 4" to the Agreement for skip tracing services is made and entered into by and between the City of San Diego, a municipal corporation (City), and RELX Inc. (LexisNexis) as of the Effective Date described herein. Each of the City and LexisNexis may be referred to herein as each a "Party" or collectively, the "Parties."

RECITALS

WHEREAS, San Diego Data Processing Corporation (SDPPC) previously provided certain information technology-related procurement services to the City; and

WHEREAS, SDDPC entered the agreement with Lexis Nexis on behalf of its customer, the City, to provide services set forth therein related to access to the Accurint program used for skip tracing services on an as-needed basis by the City; and

WHEREAS; there are two accounts that are covered by the agreement with Lexis Nexis with a corresponding Schedule A with pricing; one is the transactional account that bills based on transactions and includes batch services and the other is a per user subscription access (collectively known as the Agreement); and

WHEREAS, the transactional account was created pursuant to the Agreement executed on July 31, 2008; and

WHEREAS, the per user subscription account was created pursuant to the Agreement executed on October 29, 2009; and

WHEREAS, the batch services were added to the transactional account pursuant to the Agreement on September 23, 2011; and

WHEREAS, effective on January 1, 2012, the LexisNexis Agreement was assigned by SDPPC to the City pursuant to a letter agreement dated November 22, 2011; and

WHEREAS, on August 1, 2012, the Purchasing and Contracting Department Director approved a Sole Source Request for this Agreement with LexisNexis through June 30, 2013; and

WHEREAS, on July 17, 2013, the Purchasing and Contracting Department Director approved a Sole Source Request for this Agreement with LexisNexis through June 30, 2014; and

WHEREAS, on June 11, 2014, the Purchasing and Contracting Department Director approved a Sole Source Request for this Agreement with LexisNexis through June 30, 2017; and

WHEREAS, on October 19, 2016, the Purchasing and Contracting Department Director approved a Sole Source Request for this Agreement with LexisNexis for an additional term of five years; and

WHEREAS, a new Schedule A was put in place for both the transactional, batch services, and user subscription accounts to provide better pricing and took effect with Amendment No. 1 to the Agreement (Amendment No. 1), which was effective as of January 1, 2017; and

WHEREAS, on September 9, 2021, the Purchasing and Contracting Department Director approved a Sole Source Request and Certification Form for that certain "Amendment No. 2" to the Agreement (Amendment No. 2) for an additional term of one (1) year; and

WHEREAS, the City entered into Amendment No. 2 to extend the Agreement through December 31, 2022; and

WHEREAS, on May 12, 2022, the Purchasing and Contracting Department Director approved a Sole Source Request and Certification Form for that certain "Amendment No. 3" to the Agreement (Amendment No. 3) for an additional term of one (1) year; and

WHEREAS, the City entered into Amendment No. 3 to extend the Agreement through December 31, 2023; and

WHEREAS, on August 4, 2023, the Purchasing and Contracting Department Director approved a Sole Source Request and Certification Form for this Amendment No. 4 for an additional term of four (4) years; and

WHEREAS, based on the foregoing, the City wishes to extend the Agreement for an additional term of four (4) years through December 31, 2027 upon the Effective Date of this Amendment No. 4; and

NOW, THEREFORE, the City and LexisNexis agree as follows:

1. The "Effective Date" for this Amendment No. 4 shall be January 1, 2024, upon the signatures of the Parties and the City Attorney.

- 2. Pursuant to this Amendment No. 4, the term of the Agreement shall be extended by four (4) years until December 31, 2027, unless terminated earlier in accordance with the terms of the Agreement.
- 3. Pursuant to this Amendment No. 4, the Agreement shall not exceed a value of \$100,000 for each additional year, totaling a maximum of \$400,000.
- 4. All other terms and conditions of the Agreement (as amended) remain in full force and effect and the Master Service Agreement No. 5-23-70-40-01 is incorporated herein by reference and made part of this Amendment 4.

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AMENDMENT NO. 4 TO THE AGREEMENT FOR SKIP TRACING SERVICES BETWEEN THE CITY OF SAN DIEGO AND LEXISNEXIS RISK SOLUTIONS FL, INC. TO EXTEND SUCH AGREEMENT BEYOND FIVE YEARS AND TO OBTAIN EXPENDITURE AUTHORIZATION.

WHEREAS, San Diego Data Processing Corporation (SDDPC) previously provided certain information technology-related procurement services to the City; and

WHEREAS, SDDPC entered into an agreement (as amended, the Agreement) with LexisNexis Risk & Information Analytics Group, Inc. (now named LexisNexis Risk Solutions FL, Inc., LexisNexis) on behalf of its customer, the City, to provide skip tracing services for the City Treasurer's Delinquent Accounts Program; and

WHEREAS, effective on January 1, 2012, the Agreement was assigned by SDDPC to the City pursuant to a letter agreement dated November 22, 2011; and

WHEREAS, since August 1, 2012, the Purchasing and Contracting Department Director has approved four (4) separate Sole Source Requests for the Agreement; and

WHEREAS, the Council of the City of San Diego (Council) authorized via Ordinance No. O-20777 an amendment to the Agreement effective as of January 1, 2017 (Amendment No. 1), which amendment modified certain terms of the Agreement, including extending its term through December 31, 2021; and

WHEREAS, the Council authorized via Ordinance No. O-21438 a second amendment to the Agreement (Amendment No. 2) extending the term of the Agreement for an additional term of one (1) year at a maximum contract amount of \$75,000; and

WHEREAS, now through a fourth amendment to the Agreement (Amendment No. 4), the City seeks a four (4) year extension of the term of the Agreement to December 31, 2027, at a total not-to-exceed amount of \$400,000, expected to be expended across five fiscal years as follows: \$50,000 in FY24, \$100,000 in FY25, \$100,000 in FY26, \$100,000 in FY27, and \$50,000 in FY28; and

WHEREAS, all other terms and conditions of the Agreement shall remain in full force and effect; and

WHEREAS, on August 4, 2023, the Purchasing and Contracting Department Director approved a Sole Source Request and Certification Form for Amendment No. 4; and

WHEREAS, on September 13, 2023, the Council Committee on Budget and Government Efficiency voted to recommend approval of this Amendment No. 4 by the full Council; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; and

WHEREAS, the Office of the City Attorney has drafted this Ordinance based on the

information provided by City staff, with the understanding that this information is complete, true,

and accurate; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on

behalf of said City, Amendment No. 4, which includes an extension of the term of the

Agreement for an additional four (4) years.

Section 2. That the expenditure of an amount not to exceed \$400,000 is authorized

for the purpose of executing Amendment No. 4, contingent upon the authorization of the fiscal

year budget and provided that the Chief Financial Officer or designee certify funds are or will be

available for such purposes.

Section 3. That a full reading of this Ordinance is dispensed with prior to its passage.

Section 4. That this Ordinance shall take effect and be in force on the thirtieth day

from and after the date of its final passage.
