REVISED NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Juneteenth COMMUNITY PLAN AREA: Peninsula COUNCIL DISTRICT: 2 LOCATION: NTC - Preble Field Liberty Station

PROJECT DESCRIPTION: Special Event Permit for a cultural festival/celebration event that would include food trucks, onsite food preparation, vendors, entertainment, sound amplification and the temporary use of a stage, tents, generator, portable restrooms, and recycling/trash containers, and that would occur at NTC Park in Liberty Station on June 16, 2024. Noise associated with the event activities and set-up/dismantling would occur from 9 AM until 7 PM on June 16, 2024. On June 16, 2024, set-up would occur from 9 AM until 11 AM, the event would occur from 12 PM until 7 PM, and dismantling would occur from 6:30 PM until 7 PM. There would be a stage for entertainment and sound amplification would occur from 12:30 PM until 7 PM. Approximately 800 attendees are anticipated throughout the course of the event.

Parking closures would be associated with this event and would occur on June 16, 2024, from 9 AM until 7 PM, and would include the parking spaces on Cushing Road in front of the cannons.

There would be no street closures associated with the event.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
