### NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit - Mira Mesa Independence Day Fun Day and Parade
COMMUNITY PLAN AREA: Mira Mesa

LOCATION: Gold Coast Dr., Hourglass Park, 10440 Black Mountain Rd, San Diego, CA 92126

**PROJECT DESCRIPTION:** Special Event Permit for a community picnic and parade that would include a parade, floats, decorated vehicles, marching bands, a car show, food trucks, entertainment, sound amplification, the temporary use a stage, tents, a generator, trash/recycling containers, and portable restrooms on July 3, 2024. The community picnic would take place at Hourglass Park. See parade route map attached. Noise associated with the event activities and set-up/dismantling would occur from 8 AM until 11 PM on July 3, 2024. On July 3, 2024, set up would occur from 8 AM until 4 PM, the event would occur from 4 PM until 9:30 PM, and dismantling would occur from 9:30 PM until 11 PM. There would be a stage for entertainment and sound amplification would occur from 3 PM until 9:30 PM. Approximately 4,000 attendees are anticipated throughout the course of the event. The parade would take place within the Miramar College campus. See map for parade route attached.

There would be no road/street closures associated with this event.

Parking closures would be associated with this event and would occur from 8 AM until 9 PM on July 3, 2024, and would include a portion of the Recreation Center parking lot, for the Car Show. See map attached.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or

no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.



The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.


## Hourglass Park & Field House Map

#### Mira Mesa Town Council - Car Show Map


## Hourglass Park & Field House Map
