PROJECT DESCRIPTION: The City of San Diego's Fleet Operations Division, pursuant to the Climate Action Plan (CAP), proposes to install Electric Vehicle Supply Equipment (EVSE) at City-owned properties, listed above, to allow fleet vehicle drivers to charge their Zero Emission Vehicles (ZEVs). The EVSE will be made available behind a secure fence and intended for use only by drivers of City fleet vehicles.

The City's Climate Action Plan outlines a goal to ensure that 100% of Light Duty fleet vehicles and 75% of Medium- to Heavy-Duty vehicles are ZEVs by 2035. This requires the purchase of ZEVs to replace traditional internal combustion engines and vehicle charging equipment to maintain long-term operations of the vehicle.

The City's Department of General Services (DGS) has identified Rose Canyon Operations Yard as a top priority for electrification due to fleet vehicle operations, the number of vehicles assigned to this location and ZEVs being purchased.

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities), Section 15303 (New Construction or Conversion of Small

Structures), Section 15304 (Minor Alterations to Land), and Section 15311 (Accessory Structures)

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301 (Existing Facilities) which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use; Section 15303 (New Construction or Conversion of Small Structures) which consists of construction and location of limited numbers of new, small facilities or structures; installation of small new equipment and facilities in small structures; and the conversion of existing small structures from one use to another where only minor modifications are made in the exterior of the structure; Section 15304 (Minor Alterations to Land) which consists of minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees except for forestry or agricultural purposes; and Section 15311 (Accessory Structures) which consists of construction, or placement of minor structures accessory to (appurtenant to) existing commercial, industrial, or institutional facilities. The exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked before or on the final date of the appeal.
