NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Scripps Ranch Civic Assoc. 53rd Annual 4th of July Parade - 2024
COMMUNITY PLAN AREA: Scripps Miramar Ranch
COUNCIL DISTRICT: 5
LOCATION: Ironwood Rd, Courtyard Dr, Red Rock Dr. Red Cedar Dr, and Scripps Ranch Blvd.

PROJECT DESCRIPTION: Special Event Permit for an annual 4th of July parade event that would occur on July 4, 2024, and would include a parade route, decorated cars, animals, sound amplification, entertainment, the temporary use of portable restrooms, trash/recycling containers. Noise associated with the event activities and set-up/dismantling would occur from 6 AM until 1:30 PM on July 4, 2024. Set-up would occur from 6 AM until 9 AM, the event would occur from 10 AM until 12 PM, and dismantling would occur from 12:10 PM until 1:30 PM. There would be a public announcement system and sound amplification would occur from 10 AM until 12 PM on July 4, 2024. The parade would begin at 10 AM at Red Cedar Drive, then turn left onto Ironwood Road, turn right onto Courtyard Drive, curve to the left onto Red Rock Drive, turn right onto Scripps Ranch Boulevard, and end at Aviary Drive intersection. Road and parking closures would occur on July 4, 2024, from 6 AM until 1:30 PM and would include Scripps Ranch Boulevard between Ironwood Road and Aviary Drive, Aviary Drive between Scripps Ranch Boulevard and Red Cedar Drive, Red Cedar Drive between Aviary Drive and Mesa Madera Drive, Ironwood Road between Red Cedar Drive and Scripps Ranch Boulevard, Red Rock Drive between Ironwood Road Drive and Scripps Ranch Boulevard.

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for

causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
