## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - 71st Annual Over The Line Tournament
COMMUNITY PLAN AREA: Mission Bay Park
COUNCIL DISTRICT: 2
LOCATION: Fiesta Island in Mission Bay Park

PROJECT DESCRIPTION: Special Event Permit for an Over-The-Line sand softball tournament that would include the temporary use of teams, sand courts, merchandise vendors, food vendors, onsite food preparation, food trucks, beer garden, alcohol consumption areas, fencing/barriers, generator, entertainment, portable restrooms, trash/recycling containers, canopies/tents, tables, and chairs that would occur on Fiesta Island in Mission Bay Park on July 12-14, 2024, and July 20-21, 2024. Alcohol would be served on July 12, 2024, from 12 PM until 3:30 PM, on July 13, 14, and July 20, from 7 AM until 6:30 PM, on July 21 from 7 AM until 3:30 PM. During the tournament there would be overnight RV parking in a fenced, guarded area along the western side of Fiesta Island paralleling Fiesta Island Road. Noise associated with the event activities and set-up/dismantling would occur from 6 AM on July 8, 2024, until 6 PM on July 23, 2024. On July 18-12, 2024, set-up for the event would occur from 6 AM until 6 PM. On July 12, 2024, unorganized team practicing, concession sales (shirts, programs), limited hospitality (members and workers) and an open beer garden would occur from 12 PM until 9 PM. The event would occur on July 12, 2024, from 12 PM until 3 PM, on July 13, 14, 20, from 7 AM until 7 PM, and on July 21, 2024, from 7 AM until 4 PM. Dismantling would occur on July 22 and 23, 2024, from 6 AM until 6 PM. There would be sound amplification from announcements and would occur from 7 AM until 7 PM during event dates listed above.

No road closures would be associated with this event.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for

causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
