NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Disaster Relief Trials SOCAL
COMMUNITY PLAN AREA: North Park, Uptown, Balboa Park
COUNCIL DISTRICT: 3
LOCATION: North Park Mini Park, surrounding roadways and pathways in Balboa Park, Uptown, North Park (see attached maps)

PROJECT DESCRIPTION: Special Event Permit for a race and fair event that would occur surrounding roadways and pathways in Balboa Park, North Park, and Uptown, on August 10, 2024, and would include the route shown on the attached map, vendors, carnival, music, demonstrations, food, food trucks, the temporary use of generators, sound amplification, tents, trash/recycling containers, and portable restrooms. The start and finish line would take place on North Park Way adjacent to the Mini Park. Noise associated with the event activities and set-up/dismantling would occur from 7 AM until 7 PM on August 10, 2024. Set-up would occur from 7 AM until 8:30 AM, the event would occur from 9 AM until 6 PM, and dismantling would occur from 6 PM until 7 PM.

The following road and parking closures would be associated with this event on August 10, 2024, from 7 AM to 7 AM: North Park Way between 29th Street and Granada Avenue.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
