## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

**PROJECT NAME:** Special Event Permit - Pacific Beach Car Show **COMMUNITY PLAN AREA:** Pacific Beach **COUNCIL DISTRICT:** 2 **LOCATION:** Garnet Ave from Mission Blvd to Everts Street (see attached map)

**PROJECT DESCRIPTION:** Special Event Permit for a car show on Garnet Ave from Mission Blvd to Everts Street on August 10, 2024. The event would include a show of cars, a stage, portable restrooms, trash/recycling containers, performances, and sound amplification from 10 AM to 2 PM (sound check at 9:30 AM). Noise associated with the event would occur from 7 AM to 3 PM on August 10, 2024. Set up would occur from 7 AM to 9:30 AM, the event would occur from 10 AM to 2 PM, and dismantling would occur from 2 PM to 3 PM.

Roads would be closed on August 10, 2024, from 7 AM to 3 PM on Garnet Avenue from Mission Blvd. to Everts St, on Bayard St. to alley, Cass St. to alley, Dawes St. to alley. See map attached.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no

significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.



You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
