## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

PROJECT NAME: Special Event Permit - Hillcrest CityFest 2024

**COMMUNITY PLAN AREA:** Uptown

**COUNCIL DISTRICT: 3** 

LOCATION: Fifth Ave. between University and Brookes Avenues, Robinson Ave. between Fourth and

Sixth Avenues, Pennsylvania Ave between 4th and 6th Avenues

**PROJECT DESCRIPTION:** Special Event Permit for an urban festival on August 11, 2024, on 5th Avenue between University and Brookes Avenues. The event would include the temporary use of tents, onsite food preparation, food trucks, generators, fencing and or barriers, tables, chairs, live performances, sound amplification, alcohol, food vendors, merchandise vendors, tables, chairs, fenced-in beer gardens, a stage, and entertainment. Noise associated with the event activities and set-up/dismantling would occur from 3 AM on August 11, 2024, to 3 AM on August 12, 2024. Set-up for the event would occur on August 11, 2024, from 3 AM until 12 PM, the event would occur from 12 PM until 11:15 PM, and dismantling would occur from 11:15 PM on August 11, 2024, through 3 AM August 12, 2024. The expected attendance would be approximately 10,000.

Road closures would occur from 4 AM on August 11, 2024, until 3 AM on August 12, 2024, on Fifth Avenue between University and Brookes Avenues, Robinson Avenue between 4<sup>th</sup> and 6<sup>th</sup> Avenues, Pennsylvania Avenue between 4<sup>th</sup> and 6<sup>th</sup> Avenues, University Ave from 6<sup>th</sup> Ave to 4<sup>th</sup> Avenue.

Parking closures associated with the event would occur from 3 AM on August 11, 2024, to 3 AM August 12, 2024, and would include Fifth Avenue between University Avenue and Brookes, Robinson Avenue between 4th and 6th Avenue, Pennsylvania Avenue between 4th and 6th Avenue, West side of 5th Ave (north of University) in front of Union Bank, Evans Place between 5th and 6th Avenue, Anderson from 5th to 6<sup>th</sup>, and Brookes between 4th and 5th Avenue, along with the bike lane on west side of 5<sup>th</sup> Ave. from Robinson to Pennsylvania.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

## ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
