Item 1: World Athletics Road Running Championships-San Diego 2025 presenter Tracy Sundlun, WARRC requesting to host the 2025 World Athletics Road Running Championships in Balboa Park. The event will consist of 3 different races dates with multiple races on the first two days. The event will set up on the lawns along 6th Avenue from Laurel South Lawn up to Upas Street beginning Tuesday, September 23, 2025 at 8:00 a.m. through Thursday, September 25, 2025 at 4:00 p.m. The first race will be held on Friday, September 26, 2025 for the 1 Mile Championships with the first race starting at 1:30 p.m. The 1 Mile Championships will have 16 races every 20-25 minutes with the last race starting at 4:35 p.m. No bridge closure of Friday, September 26, 2025. The second race will be held on Saturday, September 27, 2025 for the 5K Championships with the first race starting at 7:00 a.m. The 5K Championships will have 11 races every 25-30 minutes with the last race starting at 10:45 a.m. The bridge will reopen by 11:00 a.m. on Saturday, September 27, 2025. The third race will be held on Sunday, September 28, 2025 for the half Marathon Championship. The half Marathon race will start at 6:30 a.m. and the bridge will reopen by 8:30 a.m. on Sunday, September 28, 2025. The event will load out on Monday, September 29, 2025 from 8:00 a.m.-4:00 p.m.
