or external arts and cultural events. J. Fields mentioned that if a budget or donation would like to be made, Kim Phillips-Pea, who is the chairperson for the MLK Day Arts and Culture Committee, would be her first recommendation to be the artist.

<u>PUBLIC SAFETY COMMITTEE:</u> T. Van reported the security camera initiative has begun and is continuing. Also reported that there are public parking concerns and overnight loitering. Service calls to PD has been made to ensure park safety which is required for park activation. J. Fields stressed the importance of making multiple service calls to show the need for patrols. C. Jones recommends the addition of private security due to new laws regarding overnight parking that limits PD jurisdiction.

<u>CHAIRPERSON'S REPORT:</u> J. Fields reported that she has an upcoming meeting with Andy Field and Gina Dulay to discuss the 2025 MLK Sportsfest and Celebration. J. Fields also reported that families still affected by the devastating January floods can still receive resources through a Southeast resource group out of the Jackie Robinson YMCA on Mondays at 6pm and that there was a 6-week extension for shelter availability. J. Fields encourage community members to share these resources to anyone who was affected or may benefit from them.

<u>SDPD CRO</u>: C.
