NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit - Aloha Run **COMMUNITY PLAN AREA:** Mission Bay Park

COUNCIL DISTRICT: 2

LOCATION: Tecolote Shores South Park, pathways within Mission Bay Park, North Mission Bay Drive,

De Anza Road

PROJECT DESCRIPTION: Special Event Permit for a 10K/5K run event that would include the routes as shown on the attached maps, vendor expo, a stage, generators, entertainment, music, sound amplification, portable restrooms, canopies, onsite food preparation, food trucks, trash/recycling containers, tables, and chairs on September 8, 2024. Noise associated with the event activities and set-up/dismantling would occur from 9 AM on September 07, 2024, to 1 PM on September 8, 2024. Set-up would occur from 9 AM until 6 PM on September 7, 2024, the event would occur from 5 AM until 11 AM on September 8, 2024, and dismantling would occur from 11 AM until 1 PM on September 8, 2024. The expo set up and the run/walk routes for both the 5K and 10K are shown on the attached maps.

The following road closures including parking closures on September 8, 2024, from 7 AM to 9 AM would be as follows: on De Anza Road (northbound) from Bayside Walk to North Mission Bay Drive and on North Mission Bay Drive (westbound) from De Anza Road to the pedestrian Bridge to Mission High School.

Parking closures would be associated with this event and would include Telcolote Shores South parking lot and Sun Runner parking lot on September 8, 2024, from 5 AM until 12 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for

causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.


