## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - ENVZN Urban Artist Takeover- A World Design Capital San Diego Tijuana 2024
COMMUNITY PLAN AREA: Balboa Park
COUNCIL DISTRICT: 3
LOCATION: 30th Street between Commercial Street and the alley

**PROJECT DESCRIPTION:** Special Event Permit for a performing arts festival event, that would occur in Balboa Park on September 14, 2024, and would takes place within the Soap Factory Event Center and 30th Street between Commercial Street and the alley. The event would include live performances, music, a fashion show, entertainment, food, onsite food preparation, food trucks, alcohol, the temporary use of, vendor booths, portable restrooms, trash/recycling containers, tables, chairs, fencing and/or barriers, canopies, sound amplification, and a generator. Noise associated with the event activities and set-up/dismantling would occur from September 13, 2024, at 10 AM to September 15, 2024, at 6 AM. Set-up would occur on September 13, 2024, from 10 AM until 9 PM, and on September 14, 2024, from 8 AM until 12:30 PM. The event would occur on September 14, 2024, from 10:30 PM until September 15, 2024, at 6 AM.

Road and parking closures would occur from 2 PM on September 13, 2024, until 6 AM on September 15, 2024, and would include south curb line of Commercial from 29<sup>th</sup> to 31<sup>st</sup> Streets, both sides of 30<sup>th</sup> from the alley to Commercial, and the road would be closed to thru traffic on 30<sup>th</sup> Street from the alley to Commercial Street.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
