NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit - Music Box's 10 Year Anniversary **COMMUNITY PLAN AREA:** Downtown **COUNCIL DISTRICT:** 3 **LOCATION:** India Street; 1337 India Street, 92101

PROJECT DESCRIPTION: Special Event Permit for a private block party, 21 and over, event that would include the temporary use of a stage, seating, entertainment, a drone bar, onsite food preparation, food trucks, alcohol, tents/canopies, lighting, generator, fencing and/or barriers, portable restrooms, recycle/trash containers, tables, and chairs, to occur in Downtown area on India Street from West A Street to West Ash Street, on September 14, 2024. Alcohol would be served from 3 PM until 10:30 PM on September 14, 2024. Noise associated with the event activities and set-up/dismantling would occur from 12 AM on September 14, 2024, until 6 AM September 15, 2024. A stage would be used for entertainment, and sound amplification would occur from 8 AM until 11 PM. On September 14, 2024, set-up would occur from 12 AM until 3 PM, and the event would occur from 3 PM until 11 PM. Dismantling would occur from 11 PM on September 14, 2024, until 6 AM on September 15, 2024. Approximately 3,500 attendees are anticipated throughout the course of the event.

Road/street and parking closures would be associated with the event and would occur from 12 AM on September 14, 2024, until 6 AM on September 15, 2024, and would include India Street between W. A Street and W. Ash Street.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
