ITEM 1: 873 SAN ANTONIO PLACE - PROJECT NO. 1071329

Staff: Chandra Clady City Council District: 2 Plan Area: Peninsula

Coastal Development Permit for the remodeling and 887-square-foot addition to a 4,257 square-foot existing single dwelling unit located at 873 San Antonio Place. The project consists of the remodeling of an existing basement and main level, and the addition of 887 square-feet to the first and second floors, resulting in a 5,144 square-foot single dwelling unit. The 0.21-acre site is in the RS-1-7 Zone. The applicable site overlays are Coastal Overlay Zone (Appealable), and Coastal Height Limit Overlay Zone. The project is categorically exempt from the California Environmental Quality Act (CEQA) per Section 15301 (Existing Facilities) of the CEQA Guidelines. Report No. HO-24-031.

ITEM 2: GRANGER OFF-SITE ALCOHOL SALES - PROJECT NO. 1102259

Staff: Johnwilly Aglupos **City Council District:** 3 **Plan Area**: Downtown

Conditional Use Permit for alcoholic beverage sales for off-site consumption within a 2,112-square-foot food and retail store, currently under construction on the ground level of the Granger Building, located on the 12,500-square-foot site at 449 Broadway Avenue at the southwest corner of Fifth Avenue and Broadway Avenue in the Gaslamp Quarter Planned District of the Downtown Community Plan Area and Transit Priority Area Overlay. The project is consistent with the previously certified Downtown Final Environmental Impact Report as amended and no additional environmental document is required under the California Environmental Quality Act. Report No. HO-24-033.

ITEM 3: 8341 LA JOLLA SCENIC DRIVE - PROJECT NO. 1104699

Staff: Will Rogers City Council District: 1 Plan Area: La Jolla

Site Development Permit to build a 6,196 square-foot, two-story single dwelling unit and attached three-car garage on a vacant lot located at 8341 La Jolla Scenic Drive, APN-346-762-07-00. The 0.58-acre site is in the LJSPD-SF zone, Airport Land Use Compatibility Overlay Zone (MCAS Miramar), Coastal Height Limit Overlay Zone (CHLOZ), and Parking Impact Overlay Zone (Campus Impact). Categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15303(a) (New Construction). Report No. HO-24-034.

ITEM 4: 8330 PRESTWICK DRIVE - PROJECT NO. 1065876

Staff: Jose Bautista City Council District: 1 Plan Area: La Jolla

Coastal Development Permit and Site Development Permit for the demolition of an existing 2,276-square-foot single dwelling unit with an attached 506-square-foot garage and associated site improvements; and the construction of a 10,591-square-foot single dwelling unit with a basement, pool, spa, two attached garages, retaining walls, and associated site improvements. The 0.56-acre project site is located at 8330 Prestwick Drive in the La Jolla Shores Planned District – Single Family (LJSPD-SF) zone, the Coastal Overlay Zone (Non-Appealable 2), the Coastal Height Limitation Overlay Zone, the Parking Impact Overlay Zone, Very High Fire Hazard Severity Zone, and Complete Communities Mobility Choices (Mobility Zone 4) within the La Jolla Community Plan area and Local Coastal Program Land Use Plan. This project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15302 (Replacement or Reconstruction), and Section 15303 (New Construction or Conversion of Small Structure). Report No. HO-24-035.

HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. Those participating virtually may NOT cede time to others participating in person or virtually.

For Agenda Items and Non-Agenda Public Comment: Submit using the <u>webform</u>, indicating the comment type and item number (if relevant). Comments must be the business day prior for it to be distributed to Hearing Officer. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Written Materials: Instead of submitting materials as an attachment to the <u>webform</u>, you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 3rd Floor, San Diego, CA. 92101. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.
