ITEM 1: HAINE ADDITION - PROJECT NO. 1109100

Staff: Veronica Davison City Council District: 1 Plan Area: La Jolla

Site Development Permit for the construction of a 1,945-square-foot addition to an existing one-story, 2,090-square-foot, single dwelling unit with an attached 477-square-foot garage and the remodel of a 264-square-foot area of the existing dwelling unit. New construction includes a 383- square-foot first-floor addition, a 1,200-square-foot second-floor addition, a 362-square-foot garage addition, and exterior balconies located at 3001 Cranbrook Court. The 0.32-acre site is in the La Jolla Shores Planned District Single Family (LJSPD-SF) zone, the Coastal Height Limitation Overlay Zone, the Parking Impact Overlay Zone (Campus Impact), a Parking Standards Transit Priority Area, and a Transit Priority Area within the La Jolla Community Plan.

This project was determined to be categorically exempt pursuant to Section 15301(e) (Existing Facilities) of the California Environmental Quality Act. Report No. HO-24-036.

Staff: Martin Mendez City Council District: 6 Plan Area: Clairmont Mesa

Conditional Use Permit (CUP) to amend CUP No. 8276 to convert an existing church to an educational facility, with the proposed construction of 12 classrooms for infant care to fifth grade, visitor accommodations for traveling teachers and associated site improvements. Construction would occur in four phases with a total gross square footage of 15,873 square feet. The 1.2-acre site is located at 4811 Mount Etna Drive in the RS-1-7 (Residential-Single Unit) zone, the Airport

Land Use Compatibility Overlay Zone (ALUCOZ) for Marine Corps Air Station (MCAS) Miramar and Montgomery Field, the Airport Land Use Compatibility Plan (ALUCP) Airport Influence Area (AIA) Review Area Two for MCAS Miramar and Montgomery Field, the Federal Aviation Administration (FAA) Part 77 Noticing Area, the Clairemont Mesa Height Limit Overlay Zone (CMHLOZ), a Transit Priority Area, and the Very High Fire Hazard Severity Zone (VHFSZ) within the Clairemont Mesa Community Plan.

This project was determined to be categorically exempt pursuant to Section 15332 (In-fill Development) of the California Environmental Quality Act. Report No. HO-24-038.

ITEM 3: 2126 SAN CLEMENTE CONDOMINIUMS - PROJECT NO. 1105781

Staff: Francisco Mendoza **City Council District:** 2 **Plan Area**: Peninsula

Tentative Map Waiver to convert four dwelling units under construction into residential condominium units (two duplex buildings totaling 7,309 square feet) located at 2126, 2124, 2128 San Clemente Street and 4109 Udall Street. No construction is proposed with this Tentative Map Waiver. The 0.13-acre site is in the RM-2-5 zone, and the Coastal Height Limit Overlay Zone within the Peninsula Community Plan.

This project was determined to be categorically exempt pursuant to Section 15315 (Minor Land Divisions) of the California Environmental Quality Act. Report No. HO-24-040.

ITEM 4: 2335 PASEO DE LAS AMERICAS CANNABIS PRODUCTION FACILITY- PROJECT NO. 1107654

Conditional Use Permit to allow a previously entitled Cannabis Production Facility within a 3,000-square-foot commercial tenant space in a multi-tenant 18,096-square-foot commercial building located at 2335 Paseo de las Americas. The 1.01-acre site is in the IL-2-1 Zone within the Otay Mesa Community Plan.

This project was determined to be categorically exempt pursuant to Section 15301 (Existing Facilities) of the California Environmental Quality Act. Report No. HO-24-041.

Staff: Chandra Clady City Council District: 1 Plan Area: La Jolla

Coastal Development Permit and Site Development Permit for the demolition of an existing single dwelling unit and the construction of a new 5,137-square-foot, two-story single dwelling unit with a 1,649 square-foot basement, an attached new 408-square-foot Junior Accessory Dwelling Unit (JADU), a new detached 1,200-square-foot Accessory Dwelling Unit (ADU), a new 888-square-foot garage, and a new pool, spa and deck. The 0.51-acre site is located at 812 Havenhurst Point in the RS-1-4 Zone within the Coastal Overlay Zone and the Transit Priority Area with the La Jolla Community Plan.

This project was determined to be categorically exempt pursuant to Section 15302 (Replacement/Reconstruction) of the California Environmental Quality Act. Report No. HO-24-029.

DEPARTMENT RECOMMENDATION

Approve the project.
