



Proclamation of the City Council City of San Diego

Kelly Wood Day

WHEREAS, Kelly Wood began her distinguished career with the City of San Diego's Parks and Recreation Department in 1988 as a Recreation Aide at Kearny Mesa Recreation Center and Pool; and

WHEREAS, Kelly Wood was promoted to Recreation Leader I in 1991, and then to Recreation Leader II in 1992, where she supervised an Afterschool Playground Site; and

WHEREAS, Kelly Wood's dedicated leadership earned her a promotion to Assistant Recreation Center Director at Linda Vista Recreation Center and Community Park in 1994. Her excellent managerial abilities were further recognized in 1998 when she was promoted to Recreation Center Director I at Azalea Recreation Center and Community Park; and

WHEREAS, Kelly Wood was appointed Area Manager II in the Mira Mesa community in 2008, where she also effectively managed the Kearny Mesa, Linda Vista, and Serra Mesa communities, ultimately overseeing the Parks in the Navajo and Tierrasanta Communities; and

WHEREAS, Kelly Wood's 36 years of service in the Parks and Recreation Department exemplify exemplary dedication and leadership, as she worked across multiple divisions and served diverse communities throughout the City of San Diego; and

WHEREAS, Kelly Wood's outstanding service and contributions to the City of San Diego are evidenced by her numerous achievements, including receiving the Department's Safety and Productivity Recognition Award multiple times, as well as commendations and department awards for her stewardship of projects, programs, and events such as the Linda Vista Multi Cultural Fair, Winter Wonderland at Hilltop, the opening of Black Mountain Gym, STAR/PAL, and Toys for Tots; NOW, THEREFORE,

BE IT PROCLAIMED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby proclaim July 31, 2024 to be "Kelly Wood Day" in the City of San Diego.
