NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

CITY PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Right of Entry Permit between the City of San Diego, Balboa Park Cultural

Partnership, and Frog Parking

COMMUNITY PLAN AREA: Balboa Park

LOCATION: Balboa Park, San Diego, CA 92101

PROJECT DESCRIPTION: The scope of work for this Right of Entry Permit between the City, Balboa Park Cultural Partnership, and Frog Parking will include: installation of individual ground mounted parking sensors; installation of LiDAR detectors along entry/exit lanes; and installation of a pole mounted gateway communication device in the following parking lots within the Central Mesa: Alcazar Garden, South Pepper Grove, Carousel, NAT, North Pepper Grove (Fleet), Casa de Balboa, and Federal and Spreckles Organ Pavilion.

It is the responsibility of the permittees to obtain the necessary permits prior to commencement of any work on the project, to obtain any inspections required for the work involved and to ensure the project will adhere to all laws, rules, and regulations, including the State Historical Building Code, Title 24 of the Health and Safety Code of the State of California (Part 2.7 and Part 8); the latest edition of The Secretary of the Interior Standards for the Treatment of Historic Properties, with Guidelines for Preserving, Rehabilitating, Restoring, and Reconstructing Historic Buildings (National Park Service); California Building Code Title 24, ADA, and the latest edition of the Park and Recreation Department's Consultant's Guide to Park Design and Development, 2012 San Diego Standard Drawings for Public Works Construction the Standard Specifications for Public Works Construction (Greenbook, 2012 edition), the 2012 City of San Diego "Whitebook" supplement to the Greenbook, City of San Diego regulations and other local agencies regulations.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities)

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines

Section 15301 (Existing Facilities), which exempts the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use. The exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
