### III. Action and Informational Items (6:15-6:50 p.m.)

a. Action Item 1: Endorse or object to the proposed angle parking along the 3000 block of Monroe Avenue (between 30th Street and Ohio Street), presented by Genoveva Romero-Márquez, Assistant Engineer – Traffic. The City of San Diego is proposing to convert the existing parallel parking spaces to angle parking on Monroe Avenue between 30th Street and Ohio Street. The map below shows the proposed angle parking project. This new parking configuration will be installed on the south side of 3000 block of Monroe Avenue. This new parking configuration will add approximately 4 parking spaces. The City of San Diego provided a 60-day notice to fronting property owners and tenants along the 3000 block of Monroe Avenue. Results of the notice indicate 96% of property owners/tenants are in favor of the proposed change.
