- The mayor's office submitted the fiscal year 2025 budget. It was a difficult budget season for the City and the state of California; however, the approved budget is an improvement compared to the proposed budget, which included cuts to library and parks and recreation center hours.
- **Dennery Ranch Park:** a \$4.3M EIFD + \$500,000 City budget (\$4.8M total); they continue working through environmental issues and permitting with DSD.
- **Hidden Trails Park**: City-funded allocation of \$850K.
- Fire Station no. 49: An allocation of \$1.5M EIFD + \$500K City (\$2M total) funding.
- Palm Interstate 805 exchange: an allocation of \$5.1M.
- Beyer Park Phase 1: CIP project page for schedule and budget information. We noted that work on this site may not occur
 for several months due to biological survey requirements. Groundbreaking event details are coming soon.

ITEM #4- BLUEPRINT SAN DIEGO - Senior Planner from the City Planning Department presented the project and the changes that will be presented to the Planning Commission.

CPC Sub-committee response to BPSD- Executive Summary and Top 10 recommendations, "Blueprint SD is using the best available data to identify areas for more homes and jobs that are connected to convenient and affordable options to walk, bike, and ride transit to meet daily needs, such as going to work, school, or the grocery store. This approach helps meet the needs of our growing City while making progress toward our climate goals. This updated strategy (or "blueprint") for growth will be used to refresh the General Plan."

Public and CPC comment (Partial)

- Blueprint SD creating places where people don't want to live.
- The City continues to build affordable housing in low-resource areas
- Responses are needed to public comments along with meaningful interaction with staff.
- Putting Blueprint SD on hold until public comments are addressed.
- The City needs to plan for infrastructure before density. The City does the opposite.

Two motions were made – Motion to Oppose as presented was defeated. The Motion to approve the top ten recommendations was approved.

<u>ITEM #5- GRAND JURY REPORT</u> - A CPC member presented a review of the work of the CPC Grand Jury Subcommittee related to the Request for a County Grand Jury Investigation of San Diego Land Use Governing Practices regarding Improper Project Classifications, Improper Legislation of Municipal Code, Access and Transparency, and Municipal Code Enforcement

ITEM #6- ENVIRONMENTALLY SENSITIVE LANDS- Request to form a subcommittee to evaluate the changes being made to the Municipal Code that limits public comment about impacts on environmentally sensitive lands.

Item #8- CPG CHANGES UPDATE- The Program Coordinator from the City Planning Department updated the CPC on planning group recognition, and the next steps follow the City Council's decision.

Planning provided recommended language for allowing virtual or hybrid meetings.

ITEM #4 - INFRASTRUCTURE PRIORITIZATION- The Planning Department presented this year's CIP survey and the Infrastructure Prioritization process. https://www.sandiego.gov/planning/programs/work-programs/infrastructure-prioritization-engagement. Build Better San Diego City priorities are funded by DIF only. Prioritized CIP projects have access to a variety of funding sources. The greatest probability of realizing funding for CIP projects is for individual, Planning Group, and Council representative CIP priorities to match City Build Better San Diego priorities. **Deadlines: Public survey Aug. 1/ PG Spreadsheet Aug. 15**

- New in 2024: Planning Group CIP Prioritization Spreadsheet submittal sent to PG Chairs.
- Lobby Council member to include PG priorities in their separate prioritization submittals.

ITEM #5- - CPG REIMBURSEMENT FUNDS - CPC reviewed and discussed the \$500 reimbursement from the City and considered if PG's wants to request a larger budget for future years. Current reimbursement requests are due by the end of June.

ITEM #6- SHORT TERM VACATION RENTAL ORDINANCE (STRO) - Citizen-led initiative presented highlighting impacts of the ordinance and recommend revisions. This is in preparation for the annual review by the City Council CNS Committee in July. CPC will review their letter and proposed changes, and a copy of the presentation will follow.

ITEM #7- ENVIRONMENTALLY SENSITIVE LANDS LDC UPDATE REQUEST - Request from the ESL Subcommittee that the CPC submit a proposal to amend Article 2, Division 6 of the Land Development Code to ensure public awareness and provide the opportunity for public review and comment on Capital Improvement Projects proposed in locations where a project has the potential to affect Environmentally Sensitive Lands. The chance to request changes to the LDC is open through July 31, 2024.

Other Items:

Follow up Build Better San Diego supplanting Facilities Financing Plan.

Since enacting Citywide development impact fees, the City is currently not updating the previously adopted neighborhood PFFPs. However, they are hoping to update the Citywide Transportation Nexus Study in the next few years. When that happens, the City has offered to meet with the Otay Mesa Community Planning Group to discuss priority projects and other infrastructure needs.

In addition, we will string approximately 2 miles of new conductor wire and decommission the Otay Lakes Substation built in 1957.
