NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - 42nd Annual Adams Avenue Street Fair

COMMUNITY PLAN AREA: Normal Heights

COUNCIL DISTRICT: 3

LOCATION: Adams Community Park, Adams Avenue between 32nd and 36th Streets & half blocks north

and south of Adams Ave.

PROJECT DESCRIPTION: Special Event Permit for a two-day musical festival on September 21 & 22, 2024, along Adams Ave between 32nd Street and 36th Streets and within Adams Community Park. The event would include the temporary use of food trucks, onsite food preparation, food and craft vendors, alcohol, stages, sound amplification, entertainment, carnival rides, canopies, generators, fenced-in beer gardens, portable restrooms, trash/recycling containers, tables, and chairs. Noise associated with the event activities and set-up/dismantling would occur from 8 AM on September 16, 2024, until 4 PM on September 24, 2024. Set-up would occur over six days from 8 AM to 4 PM on September 16-19, 2024, from 7 AM until 4 PM on September 20, 2024, and from 12:05 AM to 9 AM September 21, 2024. The event would occur from 10 AM to 10 PM on September 21, 2024, and from 10 AM to 6 PM on September 22, 2024. Dismantling would occur over three days from 6 PM until 11:55 PM on September 22, 2024, and from 8 AM until 4 PM on September 23-24, 2024.

Road closures associated with the event would be as follows:

Adams Avenue will be closed from 32nd Street to 36th Street (9 blocks) from 12 AM 9/21/2024 to 11:45 PM on 9/22/2024. Cross-streets between 32nd & 36th St will also be closed 100' north and south of Adams Avenue, this includes: Bancroft St, 33rd St, Felton St, 34th St, Hawley Blvd, Mansfield St, 35th St and Wilson Ave. Additionally, School St from Hawley Blvd to Mansfield St. will also be closed.

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
