## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit - La Jolla Art and Wine Festival 2024
COMMUNITY PLAN AREA: La Jolla
COUNCIL DISTRICT: 1
LOCATION: Girard Avenue between Torrey Pines Road and Prospect Street, Wall Street between the

alley and Girard St, and Silverado between the alleys and Girard St (see attached map)

**PROJECT DESCRIPTION:** Special Event Permit for a two-day art and wine festival event on the subject streets (see attached map) on September 28-29, 2024. The event would include artwork, a family art center, a fenced-in wine/spirit/beer garden, food trucks, alcohol, onsite food preparation, a stage, generators, sound amplification, fencing and/or barriers, entertainment, dog rescues & adoption section, portable restrooms, canopies, tables, chairs, and recycle/trash containers. Noise associated with the event would occur from September 27, 2024, at 12 PM until September 30, 2024, at 6 AM. Set-up would occur from 12 PM on September 27, 2024, until 10 AM on September 28, 2024. The two-day event would occur on September 28 & 29, 2024, from 10 AM to 6:30 PM. Dismantling would occur 6 PM on September 29, 2024, until 6 AM on September 30, 2024.

Road/street closures associated with the event would occur from September 27, 2024, at 12 PM through September 30, 2024, at 6 AM on the roads shown on the attached map; Girard Avenue between Kline and Prospect Street, Girard Avenue between Kline and Torey Pines Road, Wall Street between the alley and Girard St, and Silverado between the alleys and Girard St.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
