## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

PROJECT NAME: Special Event Permit - 2nd Annual Dia De Muertos En Barrio Logan

**COMMUNITY PLAN AREA:** Barrio Logan

**COUNCIL DISTRICT:** 8

**LOCATION:** Logan Ave, S. Evan St., Sampson St., 26<sup>th</sup> St., Sicard St.(see attached map)

**PROJECT DESCRIPTION:** A Special Event Permit for the Dia De Muertos Celebration in Barrio Logan event that would take place in Barrio Logan (see attached map) on October 27, 2024. The event would include a stage, music, entertainment, sound amplification, generators, food, onsite food preparation, food trucks, vendors, canopies, fencing and/or barriers, tables, chairs, trash/recycling containers, and portable restrooms. Noise associated with the event would occur on October 25, 2024, from 8 AM to October 28, 2024, at 10 AM. Set up would occur on October 25, 2024, from 8 AM to 10 AM, the event would occur on October 27, 2024, from 6 AM to 9:30 PM, and dismantling would occur on October 28, 2024, from 8 AM to 10 AM and on October 28, 2024.

Road and parking closures associated with the event would occur from October 27, 2024, from 6 AM to 10 PM and would include 2060 block of Logan Avenue to the 2030 Block (Culdesac) block of Logan Avenue, S. Evans Street from the intersection of National Avenue to the end of the Culdesac of S. Evans Street, Sampson Street from the intersection at National Avenue to the intersection of Sampson St and Kearny Avenue, S. 26th Street from its conjunction with Logan Avenue to the intersection at National Avenue, and Sicard Street to from National Avenue to its intersection with S. 26th Street.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
