- PARKDALE SITE Completed: All flat work/concrete work, such as ped ramps, storm drain inlets and cross gutters, has been completed.
- Street paving is expected to start in September. The contractors had to pothole the whole length of Parkdale to identify with certainty the elevations of all utilities to produce a plan of action given an unexpected number of existing utilities. •
- GOLD COAST SITE
 Completed: Utility conflicts on Camino Ruiz and Gold Coast Dr and utility conflicts on Westchester Ave. and Woodlawn Dr. o Utility relocation work is ongoing and should be completed by the end of the year, assuming no additional unforeseen conditions.

- The project's most recent milestone was the completion of the underwater pipeline installed at the bottom of Miramar Reservoir, which has now reopened for onwater recreational activities. The Miramar Reservoir parking lot will be paved this fall. North City Pure Water Pipeline construction is projected to be completed in mid-2025.
