<u>APPROVAL OF THE MINUTES –</u> Motion made Katie Newbanks/Andy Kutzner to approve the December 2023 minutes as presented. Motion passed 7-0-1 with Dani Antique abstaining as she was not present.

TREASURERS REPORT - None.

CHAIRPERSONS REPORT -

- Complaints of e-bikes through the park

- Complaints people aren't picking up after their dogs in the dog pens and when walking their dogs
- compliments on fixing the lights in the parking lots
- compliments on the large signage indicating the field numbers
- a number of inquiries about tennis
- a couple of inquiries of renting the gazebo and other areas
- grill rental inquiry
- we received a large amount of public support regarding transforming the old lawn bowling area to turf for multi-recreational purposes
- we received a request for a very large church event in September, renting the gazebo and reserving two of the fields.
- After meeting with city arborists, it was agreed that the owl boxes made by the girl scouts for their silver project were just too large to install on any pole or tree. Due to my connections with the Safari Park, I was able to discuss 'donating' the owl boxes to the park. After meeting with one of the avian curators, it was agreed that Project Wildlife in Ramona would be able to make

immediate use of them. I'm happy to say that Safari Park staff was able to deliver the boxes in person for us.

CITY STAFF REPORT -

Area Manager:

- Mark Moncey introduced Tonya Thomas as our new center director. After 10 years as our center director, Eric McDonald has a new position in the Ocean Beach area
- Fields 3 through 6 have been renovated
- The security lights have been repaired
- Some ball field lights are out. An order has been put in to fix them
- The design portion of the dog park enhancement project has been completed. It will eventually
 go out to bid for contractors.
- New lights on field 2 and 4 will be installed
- We now have more staff at the center
- Mark Moncey is working with Aztec to keep the park in shape.

Recreation Center Director:

- Tonya Thomas introduced herself. She was the assistant center director here for a few years before moving to another center.
- A work ticket was put in for the water issues on field 7. They will check into the field 3 issue
- She's presently planning a spring fling. Anyone who would like to volunteer can contact her.

COMMITTEE REPORTS

Community Parks I Area Committee – None.

Community Council – Voted on a letter pertaining to income-graded fixed electricity charges; a fundraiser to partner with the RBCC Foundation; approved the annual directors and officers liability insurance; approved a collection box for the recent flood victims; reviewed information for the annual earth day fair.

Planning Board – Approved sending a letter regarding the draft environmental justice element for the city's general plan; approved a request for the planning department to provide more time for comments on the blueprint San Diego plan and draft environmental impact report.

Ed Brown Senior Center – Kim Lang sent an email stating their board meeting is on the same night. No further information was submitted after two (2) requests.

Rancho Bernardo Tennis Club- Scott Davis submitted a report commenting they have a strong waiting list.

Dog Park Issues – trash cans need to be addressed a bit more; questions on the status of the dog park upgrade project.

Youth Sports – All are doing fine. More youth are signing up than last year. Concerns related to enough practice/play times due to space availability.

- **102.** Confirmation of Local Bands at Movies in the Park: Robin Kaufman suggested we add local band music to the events prior to the movie. She is aware of a couple of bands in the community who would be interested. Motion made Robin Kaufman/Michelle Catin to pursue this matter. Motion passed unanimously, 8-0-0.
- **103.** Purchase of New Santa Chair: Center Director Tonya Thomas proposed purchasing a new Santa Chair. The present one has several scratches on the wood frame. She found one for a little less than \$800. Motion made Michelle Castin/Katie Newbanks to obtain a new one through Kiwanis funds, not to exceed \$800. Motion passed.
