## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

PROJECT NAME: Special Event Permit - Nightmare on Normal Street 2024

**COMMUNITY PLAN AREA:** Uptown

**COUNCIL DISTRICT: 3** 

**LOCATION:** Normal Street between University Avenue and Harvey Milk Street

**PROJECT DESCRIPTION:** Special Event Permit for a Halloween party and costume competition that would occur on Normal Street between University Avenue and Harvey Milk Street, and the west side of Normal from Harvey Milk halfway to Lincoln, on October 26, 2024 (see attached map). The event would include music, a stage, entertainment, sound amplification, generators, canopies, fences and/or barriers, tables and chairs, alcoholic beverages, onsite food preparation, food trucks, food vendors, arts and crafts vendors, portable restrooms, and recycling/trash containers. Noise associated with the event activities and set-up/dismantling would occur from 10 AM on October 25, 2024, until 3 AM on October 27, 2024. Set up would occur from 10 AM to 8 PM on October 25, 2024, and from 5 AM to 10 AM on October 26, 2024. The event would follow from 10 AM to 11:15 PM on October 26, 2024. Dismantling would occur from 11:20 PM on October 26, 2024, until 3 AM on October 27, 2024.

Road and parking closures would be associated with the event and would include Normal Street between University Avenue and to Lincoln Ave., and Harvey Milk St. from Cleveland Ave to Centre St. from 10 AM on October 25, 2024, until 3 AM on October 27, 2024. Residential access to the alley / residential parking garage on Harvey Milk between Normal and Centre St and Normal and Cleveland Ave would remain open. Northbound traffic on Normal Street from Harvey Milk to Lincoln will be open for residential access from Center St. from 10 AM on October 25, 2024, until 3 AM on October 27, 2024.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
