NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit - City Heights Park & Rec Ctr. Fall Carnival COMMUNITY PLAN AREA: Mid-City: City Heights
COUNCIL DISTRICT: 9
LOCATION: City Heights Park & Rec Center - 4380 Landis Street

PROJECT DESCRIPTION: A Special Event Permit for the four-day City Heights Parks & Recreation Center Fall Carnival that would occur October 31 - November 3, 2024. The event would include carnival rides, games, onsite food preparation, food trucks, food vendors, canopies, generators, fencing and/or barriers, trash/recycling containers, and portable restrooms. Noise associated with the event would occur from October 28, 2024, at 7 AM to November 5, 2024, at 11:30 PM. Set up would occur from 7 AM to 11:30 PM on October 28, 2024, and from 7:30 AM to 11:30 PM and October 29 & 30, 2024. The four-day event would occur from 7:30 AM to 11:30 PM each day October 31 - November 3, 2024, and dismantling would occur on November 4 & 5, 2024, from 7:30 AM to 11:30 PM.

There would be no road closures associated with this event, however, additional traffic and potential delays may occur.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in

publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
