In-Person Public Comment on an Agenda Item: If you wish to address the Commission on an item on today's agenda, please complete and submit a speaker slip before the Commission hears the agenda item. You will be called at the time the item is heard. Each speaker must file a speaker slip with the Executive Director at the meeting at which the speaker wishes to speak indicating which item they wish to speak on. Speaker slips may not be turned in prior to the day of the meeting or after completion of in-person testimony. In-person public comment will conclude before virtual testimony begins. Each speaker who wishes to address the Commission must state who they are representing if they represent an organization or another person.

For discussion and information items each speaker may speak up to three (3) minutes, subject to the Chair's determination of the time available for meeting management purposes, in addition to any time ceded by other members of the public who are present at the meeting and have submitted a speaker slip ceding their time. These speaker slips should be submitted together at one time to the Executive Director. The Chair may also limit organized group presentations of five or more people to 15 minutes or less.

In-Person Public Comment on Matters Not on the Agenda: You may address the Commission on any matter not listed on today's agenda. Please complete and submit a speaker slip. However, California's open meeting laws do not permit the Commission to discuss or take any action on the matter at today's meeting. At its discretion, the Commission may add the item to a future meeting agenda or refer the matter to staff or committee. Public comments are limited to three minutes per speaker. At the discretion of the Chair, if a large number of people wish to speak on the same item, comments may be limited to a set period of time per item to appropriately manage the meeting and ensure the Commission has time to consider all the agenda items. A member of the public may only provide one comment per agenda item. In-person public comment on items not on the agenda will conclude before virtual testimony begins.

Virtual Platform Public Comment to a Particular Item or Matters Not on the Agenda: When the Chair introduces the item you would like to comment on (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Chair indicates it is your turn to speak, click the unmute prompt that will appear on your computer, tablet or Smartphone, or dial \*6 on your phone. The virtual queue will close when the last virtual speaker finishes speaking or 5 minutes after in-person testimony ends, whichever happens first.

**Written Comment through Webform:** Comment on agenda items and non-agenda public comment may also be submitted using the <u>webform</u>. If using the webform, indicate the agenda item number you wish to submit a comment for. All webform comments are limited to 200 words. On the <u>webform</u>, members of the public should select Commission on Police Practices (even if the public comment is for a Commission on Police Practices Committee meeting).

#### V. NON-AGENDA PUBLIC COMMENT

<u>Virtual Public Comment:</u> Wayne Landon (*Timestamp 4:42*) Spoke regarding audio for emergency warnings and helicopter announcements.

<u>Virtual Written Public Comment:</u> John Doe (full statement attached to minutes), spoke about specific SDPD officers who he claimed illegally detained him. He says he's a journalist who routinely covers the police department.

#### VI. CHAIR/CABINET REPORT

 The Cabinet and Executive Director met with San Diego Police Chief Scott Wahl and his leadership team on 9/25.
 The items discussed were:

- > A case that was voted on by Commissioners to take to the Chief (details presented in Closed Session).
- ➤ Internal Affairs responses when the CPP sends cases back. Internal Affairs stated that if the CPP disagrees with their response, they are always open to discussing it.
- The CPP shared concerns about alleged comments by an SDPD officer at a community meeting. The officer allegedly told the group that the CPP is making radical recommendations that will hinder their police work and asked for community support to oppose the changes. The Chief and the leadership team agreed that it was inappropriate and will address it.
- The Cabinet updated Chief Wahl on the Ad Hoc Committees' progress.
- Update on Ad Hoc Committees provided by the Chairs:
   CPP Policy Manager, Aaron Burgess, is working closely with the Ad Hoc
   Committees to guide them on the process and the recommendations. Mr.
   Burgess is working to make sure the recommendations are in a more readable
   format, as well as keeping the format consistent for all committees.
  - Pursuits Ad Hoc Committee The paralegals have completed their analysis of CHP pursuit data. The committee will seek input from the San Diego Police Department through a PD Liaison.
  - Pretext Stops Ad Hoc Committee The Committee is finalizing the recommendations and have invited Andrea Guerro, Executive Director of Alliance San Diego and statewide Chair of the RIPA Board, to their next meeting to get her insight and feedback.
  - Protest Policy Ad Hoc Committee At an upcoming meeting, the Commission will incorporate community feedback to revise and approve a set of recommendations to update SDPD's First Amendment Activity Facilitation (4.17) procedure.
- Since forming the three Standing Committees (Training and Continuing Education, Community Outreach, and Rules Committees), the chairs have been extremely proactive about working with staff to schedule their first meetings. They will wait until after the NACOLE convention to give staff a chance to assign a staff member to work with each committee and help facilitate the meetings.
- The next CPP meeting is on Wednesday, October 23<sup>rd</sup>. The meeting will also be at Live Well San Diego.
- The Cabinet and staff will attend the National Association for Civilian Oversight of Law Enforcement Conference during the third week of October.

## VII. EXECUTIVE DIRECTOR REPORT

- Commissioners now have access to OCPP offices from Monday through Friday, 8am-5pm.
- Policy Manager Aaron Burgess and Executive Director Paul Parker met with Jerry Threet on October 1 to review and discuss his draft outside consultant report on the 153 closed cases from 2020–2023.
  - o OCPP is working to amend Mr. Threet's contract. Once the contract and draft are completed, Mr. Threet's presentation can be scheduled.
- On October 2, Outside Counsel Duane Bennett and Executive Director Paul Parker will meet with the City's HR/Labor Team to discuss their preliminary feedback to the draft operating procedures.

- Afterward, Executive Director Paul Parker will put everything together for the Operating Procedures Ad Hoc Committee to review prior to bringing the package back before the CPP for final changes prior to the Public Safety Committee (PSC). After PSC, the procedures will go to the entire City Council. After City Council it will go to meet and confer with the police union.
- Interim Standard Operating Procedures allow for the CPP to publish a summary of each case review to be published on the CPP site and documented in the semi-annual report. Outside Counsel Duane Bennett and Executive Director Paul Parker will meet to discuss how to make this happen as soon as possible.
- On October 10, Executive Assistant Alina Conde, Administrative Aide Jon'Nae McFarland, Senior Management Analyst Jamie Jacinto, Chief Investigator Olga Golub, and Executive Director Paul Parker will meet with Internal Affairs staff to discuss complaint process procedures.
- CPP Retreat; OCPP has received ten responses to Google poll regarding January meeting dates.
- Training update:
  - All commissioners have now been added to the City's online training portal, SuccessFactors.
  - Once that occurs, a few basic City-mandated trainings will be assigned to those Commissioners who have yet to complete them, the most important of which is a two-hour "Sexual Harassment" course.
  - The "CPP Overview Part 1" virtual presentation given twice by Outside Counsel Duane Bennett within the past month covering the Brown Act, Confidentiality, NACOLE Code of Ethics, and Closed Session Requirements will be uploaded to the portal and assigned to the few Commissioners who have yet to take the training.
  - Professor Fairley's "Process of Decision Making" from the 9/4 CPP meeting will be uploaded and assigned to those Commissioners who were not present.
  - Outside Counsel Duane Bennett's overview, also from September 4, 2024,
     CPP meeting, will be uploaded and assigned to those Commissioners who were not present.
- Community Engagement Coordinator Yasmeen Obeid has diligently coordinated community meetings for Executive Director Paul Parker, who met with another group last week and has a different group scheduled for next week.
- CPP Budget OCPP is assessing staffing and equipment needs
- Staffing Update These three positions will be posted soon (Deputy Executive Director, General Counsel, and Performance Auditor)
- Upcoming CPP meeting dates; November 6, November 20, December 4, and December 11.




