## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

COMMUNITY PLAN AREA:Rancho PenasquitosCOUNCIL DISTRICT:Council District 5LOCATION:Along Sundevil Way in Rancho Penasquitos (see Exhibit A)

**PROJECT DESCRIPTION:** This Right of Entry Permit would allow Mt. Carmel High School Music Foundation to use the paved road section at the top of Sundevil Way in Rancho Penasquitos for the Mt. Carmel High School Music Festival, to stage 10 - 15 school buses and to stage 40 cars for the San Diego State Marching band performers. Vehicles will access the area through the gate at the top of Sundevil Way. Vehicles will only drive and park on the existing paved road. No vegetation or soil will be impacted. Project location is not in the Coastal Zone.

## ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Sections 15301 (Existing Facilities).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

## STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301 (Existing Facilities), which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked before or on the final date of the appeal.

Bring the fully completed appeal application <u>DS-3031</u> (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.




Exhibit A: Permit Area
