ITEM 1: *SAN DIEGUITO RIVER PARK OSUNA SEGMENT OF THE COAST TO CREST TRAIL PROJECT - PRJ # 1049410

Staff: Ollie Shepherd **City Council District:** 1

Plan Area: Fairbanks Ranch Country Club

Site Development Permit (SDP) No. PMT-3138236 for the construction of the 1-mile-long Osuna segment of the Coast to Crest (CTC) Trail. The CTC Trail is a planned 71-mile-long, multi-use regional trail that will ultimately extend from the Pacific Ocean at Del Mar to Volcan Mountain, north of Julian. Approximately 49 miles of the regional trail have already been constructed and are now in use. The proposed Osuna segment of CTC Trail is located at 14555 El Camino Real, approximately two miles east of Interstate 5 between Via de la Valle and San Dieguito Road, within the Fairbanks Ranch Country Club Community Planning Area. It is included in both the Joint Powers Authority adopted San Dieguito River Park Concept Plan (1994, updated 2002) and the County of San Diego Regional Trails Plan.

A California Environmental Quality Act (CEQA) Guidelines Section 15162 consistency evaluation with the adopted Mitigated Negative Declaration SCH No. 2023050120 was prepared and it determined no subsequent environmental document is required. A Mitigation, Monitoring, and Reporting Program (MMRP) was prepared for the adopted Mitigated Negative Declaration and a subsequent MMRP will be adopted for the project. Report No. PC-24-046

ITEM 2: SKY PARK COURT - PRJ # 1074457

Staff: Christian Hoppe **City Council District:** 6 **Plan Area**: Keary Mesa

The project proposes a Tentative Map and a Planned Development Permit to subdivide an existing 170,755-square-foot parcel located at 9173 Sky Park Court into two new parcels. Parcels one and two will each maintain an existing commercial building. The project site is located at 9173 Sky Park Court and is bordered by Ruffin Road to the north and Montgomery-Gibbs Executive Airport to the south and west in the Kearny Mesa Community Plan area. The 3.92-acre site is in the IL-2-1 Zone, the Airport Land Use Compatibility Overlay Zone (MCAS Miramar and Montgomery Field), the Airport Influence Area (Review Area 1-Montgomery Field and Review Area 2 MCAS Miramar), the FAA Part 77 Notification Area (MCAS Miramar and Montgomery field), Airport Safety Zones 2,3, and 6 Montgomery Field), Parking Standards Transit Priority Area, and a Transit Priority Area.

The project was determined to be categorically exempt pursuant to the California Environmental Quality Act pursuant to CEQA State Guidelines sections 15302 (Replacement and Reconstruction) and 15304 (Minor Alterations to Land).
