## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - Our Lady of Guadalupe Procession-Diocese of San Diego

**COMMUNITY PLAN AREA:** North Park, Balboa Park

**COUNCIL DISTRICT:** 3

**LOCATION:** Morely Field-Sports Center, Upas St., 28<sup>th</sup> St., Redwood St., 32<sup>nd</sup> St.

**PROJECT DESCRIPTION:** Special Event Permit for the Our Lady of Guadalupe Procession-Diocese of San Diego event that would occur on December 1, 2024, at Morely Field-Sport Center on Upas Street between Texas and 28<sup>th</sup> St, 28<sup>th</sup> St between Upas St to Redwood St, Redwood Street between 28<sup>th</sup> Street and 32<sup>nd</sup> St, 32<sup>nd</sup> Street between Redwood St and Nutmeg Street, and check-in would take place in parking lot outside Bud Kearns Memorial Swimming Pool, Morley Field Park. (See attached maps). The event would include a procession in honor of Our Lady Guadalupe. The procession would include clergy, parish groups, floats, vehicles, banners, mariachis, bands, portable restrooms, trash/recycling containers, and dancers. Noise associated with the event activities and set-up/dismantling would occur from 7 AM until 2 PM on December 1, 2024. Set-up would occur from 7 AM until 11 AM, the event would occur from 9 AM until 1 PM, and dismantling would occur from 1 PM to 2 PM.

Road and parking closures associated with the event would occur on December 1, 2024, from 7 AM to 2 PM (rolling closures) and would include Upas Street between Texas and 28<sup>th</sup> St, 28<sup>th</sup> St between Upas St to Redwood St, Redwood Street between 28<sup>th</sup> Street and 32<sup>nd</sup> St, 32<sup>nd</sup> Street between Redwood St and Nutmeg Street, and Morley Field Sports Complex parking lot (see attached maps).

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or

no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.


