#### **ITEM 1: 6426 MOUNT ADA- PROJECT NO. 1103984**

**Staff:** May Rollin

**City Council District:** 2

**Plan Area:** Clairemont Mesa

Conditional Use Permit to allow the sale of distilled spirits at the Alta Dena Market, an existing 2,475-square-foot alcoholic beverage outlet that currently sells beer and wine. The 0.22-acre site is located at 6426 Mount Ada Road in the Commercial-Community (CC-1-3) Zone, Airport Land Use Compatibility (MCAS Miramar and Montgomery Field) Overlay Zone, and Transit Priority Area (TPA) within the Clairemont Mesa Community Plan area.

This project was determined to be categorically exempt pursuant to Section 15301, Existing Facilities, of the California Environmental Quality Act (CEQA). [Report No. HO-24-043](#).

**HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:**

**Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:** When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

**HOW TO PROVIDE WRITTEN COMMENTS:**

Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

**Late-Arriving Materials:**

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 3<sup>rd</sup> Floor, San Diego, CA. 92101. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.

Please note: Approximately one hour prior to the start of the Hearing Officer meeting, the documents will be available just outside the meeting location as identified herein in a binder labeled “Late-Arriving Materials”.
