## 101. Regional Park Improvement Fund (RPIF) Reallocation

Program Manager Ryan Barbrick indicated that project savings from the Balboa Park Botanical Building can be reallocated to other eligible Regional Park Improvement Fund projects. This action is to reallocate funding to multiple capital projects: Black Mountain Mine Remediation, Crystal Pier Improvements, El Cuervo Adobe Improvements, Golf Course Drive Improvements, and West Sycamore Staging Area.

## **Board Comment:**

Ms. Laman asked if these projects are nearing construction. Mr. Barbrick responded yes, and all projects are nearing completion.

Ms. Gross asked if any if of these projects are in communities of concern. Director Field said that none of these projects in this particular request are within communities of concern, but future requests will include communities of concern. He added that the staff will soon be introducing projects for the upcoming budget development process that will be in communities of concern, and staff will present a more thorough capital projects overview projects at an upcoming meeting.

Mr. Armstrong asked whether surplus funds should be set aside for emergency projects. Director Field responded that there are several factors to consider. our money in the projects that are already in the completion cycle and to get them off the books.

Dr. Munoz asked if it is accurate to say these surplus funds cannot be held in reserve. Director Field agreed with Dr. Munoz and that the funds must be allocated to projects and expended.
