# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**PROJECT NAME:** Special Event Permit - Little Italy Mercato

**COMMUNITY PLAN AREA:** [Downtown](#)

**COUNCIL DISTRICT:** 3

**LOCATION:** West Date Street between Front Street and Kettner Blvd cul-de-sac

**PROJECT DESCRIPTION:** Special Event Permit for a weekly farmers' market that would include the temporary use of produce vendors, merchandise vendors, food booths, onsite food preparation, entertainment, portable restrooms, canopies, trash/recycling containers, and generators, that would occur on six blocks of West Date Street between Front Street and the cul-de-sac west of Kettner Boulevard every Saturday in 2025 from January 4, 2025, to December 27, 2025. On Saturday, April 26, 2024, the Little Italy Mercato will relocate to West Cedar Street. Noise associated with the event activities and set-up/dismantling would occur from 4:30 AM until 4:30 PM on each Saturday. Set-up would occur from 4:30 AM until 8 AM, the market would be open from 8 AM until 2 PM, and clean-up/dismantling would occur from 2 PM until 4:30 PM.

A road and street parking closures would be associated with the event and would include West Date Street between Front Street and Kettner Boulevard Cul-de-Sac, from 4:30 AM until 4 PM.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in

publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.

The appeal application can also be obtained from the City Clerk, 202 'C' Street, 1<sup>st</sup> Floor Lobby, San Diego, CA 92101. This information will be made available in alternative formats upon request.

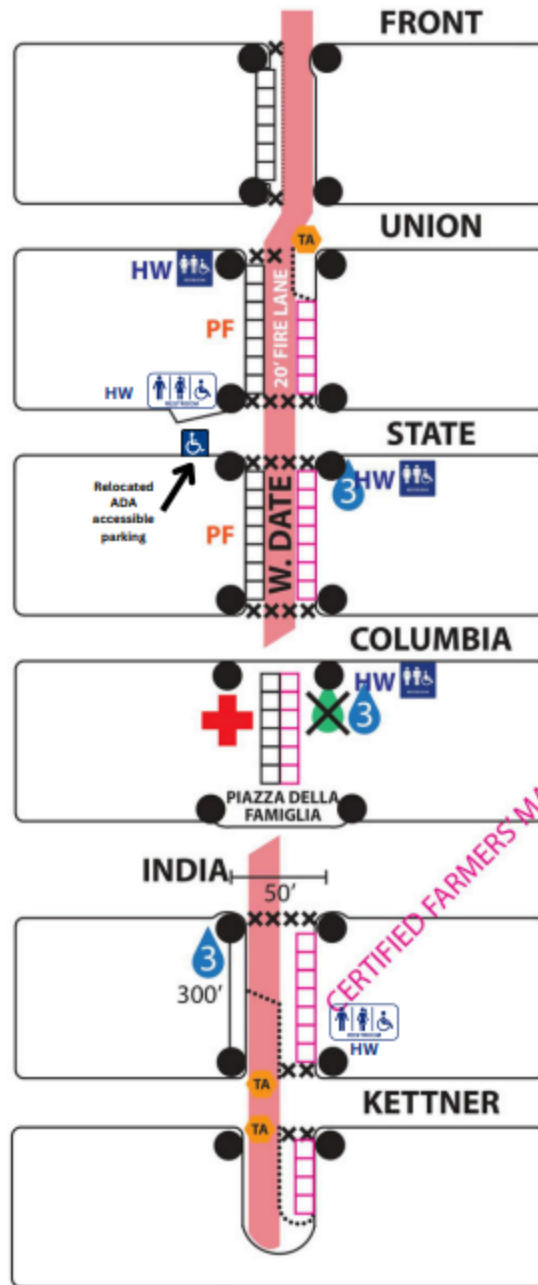
