# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - San Diego Resolution Run 5K, 10K & Half Marathon

**COMMUNITY PLAN AREA:** Mission Bay Park

**COUNCIL DISTRICT:** 2

**LOCATION:** Fiesta Island and Tecolote Shores South

**PROJECT DESCRIPTION:** Special Event Permit for the San Diego Resolution Run 5K, 10K & Half Marathon event that would occur on January 11, 2025. The event would include the routes (see attached maps & tables), vendors, food, a stage, music, entertainment, sound amplification, generators, onsite food preparation, tables, chairs, canopies, portable restrooms, and fencing and/or barriers. Noise associated with the event activities and set-up/dismantling would occur on January 10, 2025, from 10 AM to January 11, 2025, at 1 PM. Set-up would occur on January 10, 2025, from 10 AM to 6 PM, the event would occur on January 11, 2025, from 4 AM to 11:30 AM and dismantling would occur from 11:30 AM to 1 PM.

Road closures associated with the event would occur and would occur on January 11, 2025, and would include:

Fiesta Island from entrance to entrance from 5 AM through 9:30 AM,

De Anza Cove Road from 7 AM to 10 AM,

East Mission Bay Drive between Sea World Drive and Parking Lot south of San Diego Mission Bay Resort (lot stays open) from 5 AM until 9:30 AM,

North Mission Bay Dr (eastbound) from Mike Gotch Memorial Bridge to West Entrance to De Anza Cove Lot East from 7 AM to 10 AM, Parking lot south of Tecolote Shores (adjacent to new park construction) from 4 AM to 11 AM.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked before or on the final date of the appeal.

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.

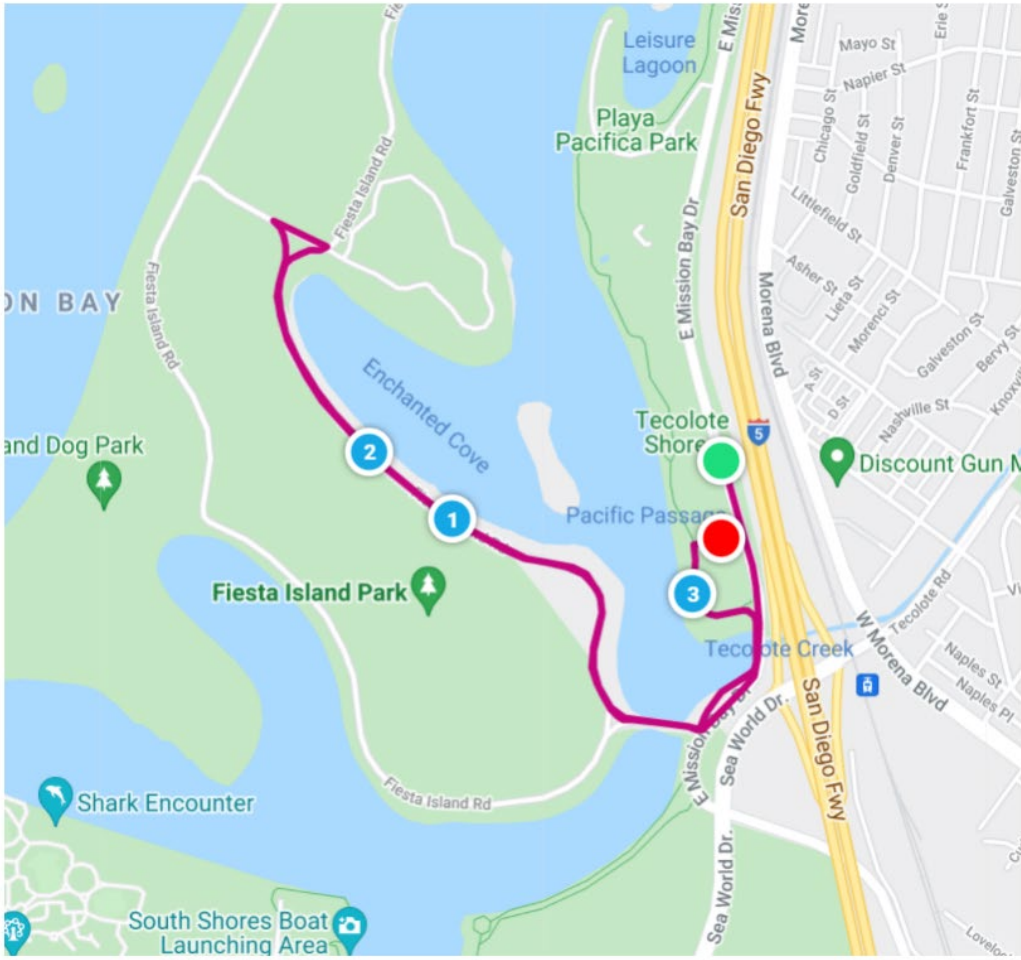

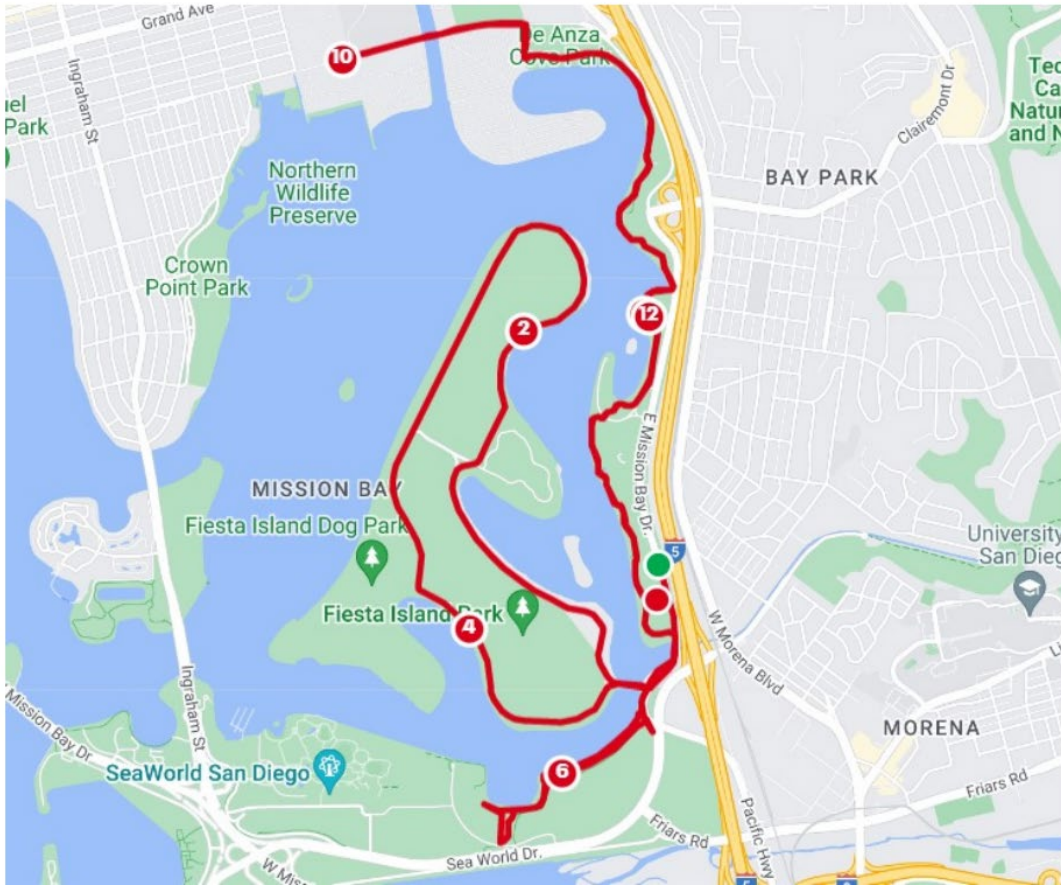
