## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - The Genesis Invitational

**COMMUNITY PLAN AREA:** University

**COUNCIL DISTRICT:** 1

**LOCATION:** Torrey Pines Golf Course, Torrey Pines Glider Port parking lot

**PROJECT DESCRIPTION:** Special Event Permit for a golf tournament that would include the use of Torrey Pines Golf Course, food vendors, food trucks, onsite food preparation, alcoholic beverages, merchandise vendors, support dogs, drones, temporary structures, sound amplification, generators, fencing and/or barriers, portable restrooms, canopies, tables, chairs, and recycle/trash containers that would occur at the Torrey Pines Golf Course. The event would occur over eight days: on February 10-17, 2025. Noise associated with the event activities and set-up/dismantling would occur at 6:30 AM from February 8, 2025, through April 4, 2025, at 6 PM. On February 8-9, 2025, set-up would occur from 6:30 AM until 5:30 PM. On February 10-17, 2025, the event would occur from 6 AM until 6 PM. On February 18, 2025, through April 4, 2025, dismantling and grounds work would occur from 6 AM until 6 PM.

Public parking would be closed from February 10, 2025, at 4 AM to February 17, 2025, at 8 PM, at the following locations unless noted as permit parking only:

- Torrey Pines Scenic Drive from North Torrey Pines Road to the ocean
- North Torrey Pines Place from North Torrey Pines Road to Callan Road (parking permit only)
- Callan Road from North Torrey Pines Road to Torreyana Road (parking permit only)
- Torreyana Road from Science Park Road to Callan Road including the cul de sac north of Callan Road (parking permit only)
- Science Park Road from Torreyana Road to North Torrey Pines Road (parking permit only)
- Callan Road from North Torrey Pines Place to North Torrey Pines Road from February 10, 2025, at 12 AM to February 18, 2025, at 6 PM, and
- La Jolla Village Drive from Genesee Ave to Executive Way

On event days, there would be partial road closures on Torrey Pines Scenic Drive as well as anticipated traffic delays on North Torrey Pines Road and Genesee Avenue.

Lot closures would occur at 2800 Torrey Pines Scenic Drive on February 9-18, 2025, at 4 AM through 8 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
