## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## CITY PLANNING DEPARTMENT

**PROJECT NAME/NUMBER:** Lease Agreement with Civic Community Partners, Inc.

**COMMUNITY PLAN AREA:** San Ysidro

**COUNCIL DISTRICT:** 8

**LOCATION:** 663 East San Ysidro Boulevard, San Ysidro, CA 92173

**PROJECT DESCRIPTION:** Under the terms and conditions of the Lease Agreement, The City hereby grants a Lease with a term from the Effective Date through June 30, 2026. The management of the San Ysidro Business Improvement District (BID) is currently the responsibility of the Economic Development Department. To support with this responsibility, the Department is contracting with Civic Community Partners to provide onsite support and engagement at the City facility in San Ysidro.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee.

## STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301 (Existing Facilities) which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use. The exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and there are locations listed on GeoTracker and EnviroStor within 1,000 feet of the address in question. While these locations are listed, the proposed projects would not involve ground disturbance, which would expose potential hazardous materials, and as such, would not preclude the use of a CEQA exemption pursuant to Section 65962.5 of the Government Code.
