NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

CITY PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Right of Entry (ROE) Permit between the City of San Diego and Diamond Design LLC.

COMMUNITY PLAN AREA: Peninsula, Linda Vista, Serra Mesa, Clairemont Mesa, Navajo, Tierrasanta, University, Mira Mesa, Scripps Miramar Ranch, Miramar Ranch North, Sabre Springs, Carmel Mountain Ranch, Rancho Bernardo, Rancho Penasquitos, Black Mountain Ranch, Pacific Highlands Ranch, Carmel Valley, Torrey Hills, Mission Bay Park, Rancho Encantada

COUNCIL DISTRICT: 1, 2, 5, 6, 7

PROJECT DESCRIPTION: Right of Entry Permit between the City of San Diego (City) and Diamond Design LLC. (Permittee) to allow the permittee access to various community parks and joint use fields to perform enhanced ballfield maintenance. The Permittee will renovate one hundred twenty seven turf outfields, infields, batter's boxes, pitching mounds, and homes plate which may include but not limited to: adding material to each field as needed, in designated areas; tilling existing infield skin; tilling prior to laser grading; taking down all high areas and opening the profile to bind new material to existing mix; laser grading infields; grading infield skin using laser guided grading box mounted on John Deere Tractor (grading includes distribution of new material per field, pre-grading scarifier, tractor work, finish drag, backfill of lips/edges and heavy watering, up to one hour post install); adding DuraEdge conditioner used post laser grade and nail dragged into the new profile to provide a top-level playing surface; providing lip removal and edges; re-establishing infield/outfield arc, and lip removal/reduction; flailing mow the edges, reducing the height of the lips, and then blowing out and using a high-pressure hose to relieve the compaction and build up that has occurred over time. The permittee will access designated Permit Area, provide all equipment, labor, and disposal.

Pursuant to this Permit, the permittee will be allowed to have these identified vehicles utilize the Permit Area daily, excluding weekends, beginning on the Effective Date and until December 31, 2028, between the hours of 8:00 a.m. and 4:00 p.m.

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Sections 15301 (Existing Facilities) and 15304 (Minor Alterations to Land)

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301 (Existing Facilities), which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use; and Section 15304 (Minor Alterations to Land), which consists of minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees except for forestry or agricultural purposes. The exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
