NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Linda Vista Multi-Cultural Fair and Parade

COMMUNITY PLAN AREA: Linda Vista

COUNCIL DISTRICT: 7

LOCATION: John P. Baca Park, 6900 block of Linda Vista Road b/w Comstock and Ulric St.

PROJECT DESCRIPTION: Special Event Permit for a free parade and multi-cultural fair event that would include floats, carnival rides, food vendors, food trucks, onsite food preparation, a fenced in beer garden, alcohol, motor vehicles, marching bands, entertainment, carnival and kid zones, vendor booths, and the temporary use of two stages, generators, portable restrooms, canopies, recycling/trash containers, chairs, and tables that would occur on April 26, 2025. Alcohol would be served from 10 AM until 4:30 PM. Noise associated with the event activities and set-up/dismantling would occur from 5 AM to 8 PM on April 26, 2025. There would be two stages with entertainment and performances, and sound amplification would occur from 10 AM until 5 PM. Set-up would occur from 5 AM until 10 AM, the event would occur from 10 AM until 5 PM, and dismantling would occur from 5 PM until 8 PM. The parade staging would occur at the San Diego Cooperative Charter School parking lot, and the parade route would travel down Linda Vista Road between Levant and Comstock Streets, turn right on Comstock Street, turn right on Morley Street, and end at Ulric Street. Parade entrants would then make their way back to the staging area along Ulric, Fulton, and Levant Streets. See map attached.

Public parking would be prohibited from 5 AM until 12 PM on April 27, 2024, on both sides of Levant between Levant Way/Fulton and Linda Vista Road, and west curb line of Linda Vista between Genesee and Ulric; and from 5 AM to 8 PM both sides of Morley between Comstock and Ulric, Ulric between Linda Vista and Eastman, and both sides of Linda Vista Road between Comstock Street and Ulric Streets.

Road closures would be associated with this event and would include Linda Vista Road between Comstock Street and Ulric Streets on April 26, 2025, from 5 AM until 8 PM, and south bound Linda Vista Road between Genesee Avenue to Ulric Streets from 10 AM until 1 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

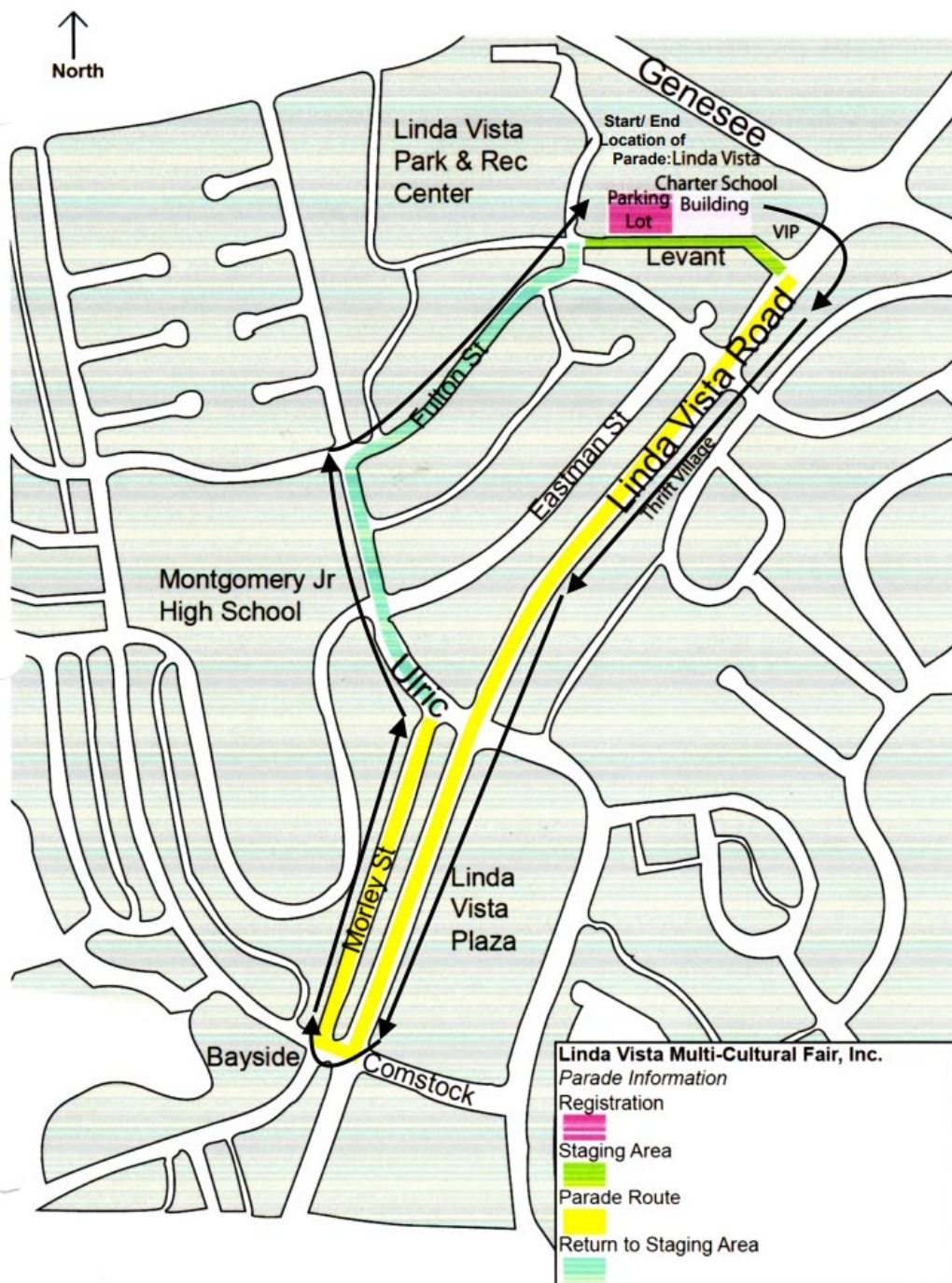

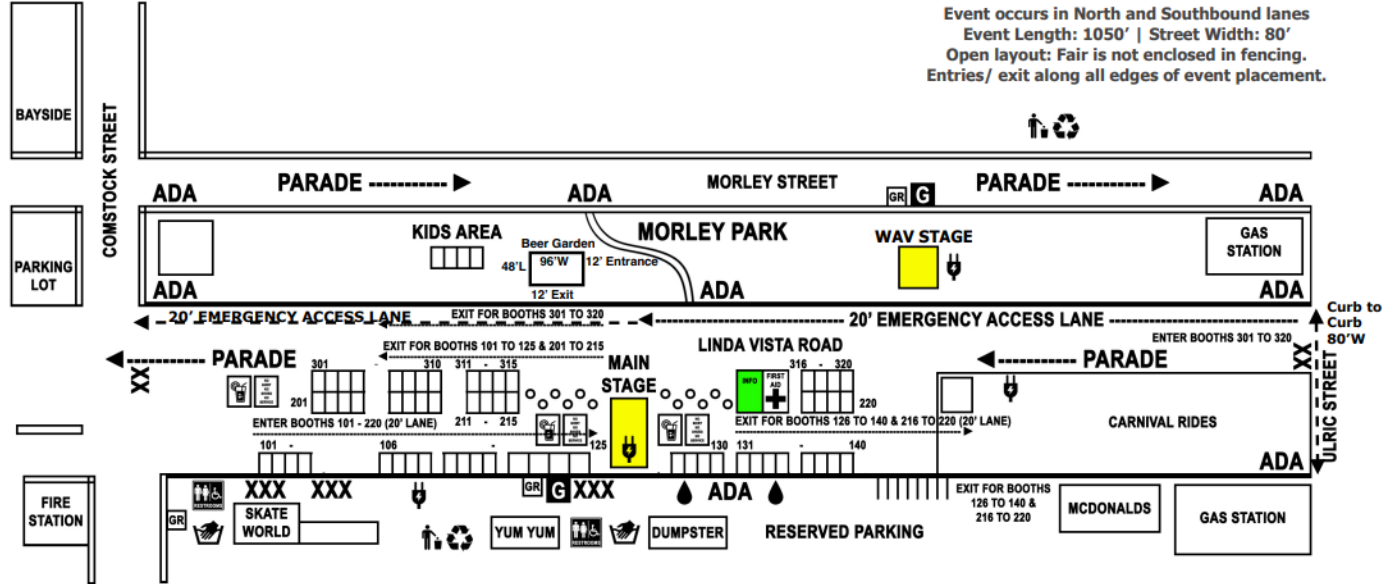
