Randy Wilde updated the board on the High-Performance Building Standards reach code effort. Since a stand-alone reach code would be largely superseded by State code updates in 2026, the High-Performance Building Standards will instead be folded into the three-year code update cycle. Mr. Wilde also updated on the City's budget review schedule and provided an update on various Federal funding sources, noting that there is increased uncertainty at the Federal level.

Item 8: Ad Hoc Committee Updates and Reports (Discussion)

- Ad Hoc Committee to Advise on CAP Reporting, Implementation, Budgets (Chair: Kelly Lyndon) Members met once in January and plan to meet again in February to develop questions for staff
- Ad Hoc Committee to Advise on Citywide Collaborative Community Awareness Campaign for EV Adoption (Chair: Cindy Lin) Members will meet towards the end of February to focus on gaps in knowledge base within the community and subcommittee with the goal of identifying timelines, partners, and milestones.
- Ad Hoc Committee to Advise on Parking Management and Revenue that Can Equitably Support the City's Mode Shift and Vision Zero Goals (Chair: JD Weidman)

Members met in January to go over the Street Design Manual and are developing the following recommendations:

- Change default travel lane width from 11-feet to 10-feet to intuitively encourage safe driving at the posted speed limit.
- Provide design requirements for grade separated and/or barrier separated bikeways instead of painted bike lanes with plastic delineators. Use NACTO design principles that support Safe Routes to School and safe bike infrastructure for children and non-vehicular cyclists.
- Provide a resolution when the City advances the Street Design Manual for Council's approval, similar to that of the City of Alameda.

Cindy Lin (member) asked for an update focused on electric vehicle efforts either in full board meeting or in EV Committee.
