#### **ITEM 1: 7356 RUE MICHAEL – PROJECT NO. 1065911**

**Staff:** Robin MacCartee

**City Council District:** 1

**Plan Area:** La Jolla

Site Development Permit, Coastal Development Permit, and Public Service Easement Vacation to demolish an existing single dwelling unit with attached garage and construct a new two story, single dwelling unit, with a 3,740-sf main level, a 2,860 sf second level, a 2,919-sf basement, a 2,779-sf attached subterranean garage, and a 1,200-sf attached subterranean ADU. The project also proposes to vacate an unused sewer easement. The 0.30-acre project site is located at 7356 Rue Michael in the La Jolla Shores Planned District-Single Family (LJSPD-SF) zone, the Coastal Overlay Zone (Non-Appealable Area), the Coastal Height Limit Overlay Zone, and the Parking Impact Overlay Zone within the La Jolla Community Plan.

The project was determined to be categorically exempt pursuant to Section 15332 (In-fill development) of the California Environmental Quality Act.

#### **ITEM 2: \*1821 VIKING WAY – PROJECT NO. 1114539**

**Plan Area:** La Jolla

Site Development Permit for an addition and remodel at an existing one-story, 2,694-square-foot single dwelling unit with an attached garage. Additions total 851 square feet. The 0.18-acre site is located at 1821 Viking Way in the La Jolla Shores Planned District Single-Family (LJSPD-SF) zone, the Coastal Overlay Zone (Non-Appealable Area), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, the Transit Area, a Parking Standards Transit Priority Area, and the La Jolla Shores Archaeological Study Area within the La Jolla Community Plan and Local Coastal Program Land Use Plan.

**ITEM 3: 630 SAN ANTONIO – PROJECT NO. 1110305**

**City Council District:** 2

**Plan Area:** Peninsula

Coastal Development Permit to demolish an existing 2,048-square-foot, two-story single dwelling unit and build a new 4,117-square-foot, two-story single dwelling unit with attached garage, landscape, hardscape, and spa. The 0.14-acre site is located at 630 San Antonio Avenue in the RS-1-7 (Residential Single Dwelling Unit) zone, the Coastal Overlay Zone (Appealable Area), the Coastal Height Limit Overlay Zone, and the First Public Roadway within the Peninsula Community Plan and Local Coastal Program Land Use Plan.

This project was determined to be categorically exempt pursuant to Sections 15301 (Existing Facilities) and 15303(a) (New Construction or Conversion of Small Structures) of the California Environmental Quality Act. [Report No. HO-25-012](#).

**ITEM 4: MARGARITAVILLE LIVE ENTERTAINMENT – PROJECT NO. 1115941**

**City Council District:** 3

**Plan Area:** Downtown

Conditional Use Permit to allow indoor and outdoor live entertainment at the Margaritaville Hotel. The 35,109-square-foot site is located at 435 Sixth Avenue at the northeast corner of Sixth Avenue and J Street within the Ballpark Mixed-Use land use district of the Centre City Planned District, a Transit Priority Area, and the East Village neighborhood of the Downtown Community Plan.

The Project is consistent with the previously certified [Downtown Final Environmental Impact Report](#) as amended and no additional environmental document is required under the California Environmental Quality Act. [Report No. HO-25-009](#).

**Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:** When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*
