The goal of police involvement at peaceful First Amendment Activities is to preserve the peace, prevent criminal activity, control traffic, and facilitate the safe exercise of an individual or group's First Amendment rights.

In furtherance of these rights, and to facilitate the safe and peaceful exercise of an individual or group's First Amendment rights, the Department will act swiftly and with resolve to protect human life, property, and maintain peace when confronted with violence, threats of violence, assaults, or other criminal acts.

Portions of this document are deemed by the San Diego Police Department to be records of security procedures and are exempt from disclosure under the California Public Records Act (CPRA), Government Code Section 7923.600.

This Critical Incident / Mobile Field Force Guide is intended to provide all personnel of the San Diego Police Department with information that is easy to retrieve and would be valuable in any emergency. This guide is not a complete listing of all information or sources. Refer to Department Procedures for a complete listing of information.

Mobile Field Force deployments are utilized, at the discretion of the Incident Commander, to assemble a set number of officers in an expedited, organized manner. Examples are:

- · Fire / Flood related evacuations and repopulation
- · Mass casualty Incidents
- · Protests and demonstrations / Civil Unrest
- · Presidential visits

FIRST AMENDMENT OF THE UNITED STATES CONSTITUTION

Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press, or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

UNLAWFUL ASSEMBLY ANNOUNCEMENT

"I am (your name & rank), a peace officer of the City of San Diego. I hereby declare this to be an unlawful assembly, and in the name of the People of the State of California, I order all those assembled at (give specific location) to immediately disperse, which means to break up this assembly.

If you do not do so, you may be arrested.

You may also be subject to other police actions including the use of kinetic energy projectiles and chemical agents, which include CS Tear Gas, OC Pepper Spray, 40mm sponge rounds, irritant filled projectiles, and 12-gauge beanbag rounds. Use of these devices could result in serious injury.


Penal Code section 409 prohibits remaining present at an unlawful assembly, which means you must leave the area I just described. If you remain in the area just described, you will be in violation of Penal Code section 409. The following routes of dispersal are available (provide evacuation routes). It is approximately XX hours, and you have XX minutes to leave the area (provide reasonable time)."

"Yo Soy (*name and rank*) un official del departamento de policia de San Diego. Por la presente declare que esta es una asambla ilegal y en el nombre del gobierno del estado de California, les ordeno a todos aquellos reunidos (*give specific location*) que se retiren inmediatamente. Usted puede moverse (give specific locations and best route). Si no hacen eso, ustedes seran arrestados.

Otra accion del policia podria incluir el uso de fuerza que podria infligir dolor significativo o causar lesiones graves. Ejemplos de esta fuerza podrian incluir projectiles de energia cinetica, agentes quimicos irritantes que incluyen, esparcidor lagrimiante, aersol de pimienta, projectiles llenos de irritante pimiento, y cartuchos calibre 12 llenos de sacos con projectiles.

Codigo Penal, seccion 409 prohibe permanecer en una asambla illegal. Si permanecen en la zona que acambos de describer, independientemente de su proposito, usted estara en violacion del Codigo Penal 409. Las Siguentes rutas de dispersion estan desponibles (provide routes). Tiene (reasonable time) minutos para dispersar."

COMMUNICATIONS PLAN

Incident Commanders or designated personnel planning for or responding to a Mobile Field Force activation, should create a communications plan.

The communications plan should take into consideration:

- Consider the need for multiple frequencies in case there are multiple events throughout the region.
- Ensure clear dialogue with Communications Division regarding Unit assignments and appropriate Unit Designators.
 - It is very important to evaluate having officers re-log with appropriate unit designators based on event type. Failing to do so creates confusion between command staff, officers, and dispatchers. Properly assigned unit designators allows for easier tracking of resources.
- Outside of an officer safety / emergency situation, squad sergeants and platoon commanders should be the only personnel speaking on the radio.





SERGEANT'S ACTIVATION CHECKLIST

- Upon a Mobile Field Force WAVE Activation, respond to the designated staging location (unless otherwise directed). All predesignated MFF personnel shall advise Communications Division when they are enroute to the staging location.
- 2. **DO NOT** respond Code 3 unless specifically directed to do so by the MFF Lieutenant / Field Lt. / Incident Commander.

- 13. Know that media has a right to enter disaster / riot scenes per 409.5(d) PC. Per 409.7 PC, media may be present behind police MFF lines.

IF YOU HAVE ANY QUESTIONS OR ARE UNCLEAR ABOUT YOUR MISSION, ASK!

CHECK-OUT PROCEDURES

- 1. Account for all personnel and equipment.
- 2. Turn in all reports to command post or prisoner processing.
- 3. Submit yellow copies of OT slips to command post, if necessary.
- 4. Have units log off of their MFF unit designator and re-log as their previously assigned unit designator.

FIELD COMMANDER MFF ACTIVATION CHECKLIST

- 1. Establish a staging location or command post.
- 2. Confirm squad officers and sergeants are enroute to the staging area via radio.

- 10. Plan for food / water for personnel.
- 11. Plan for rest / relief of line personnel.
