- San Gonzalez still works with Senator Akilah Weber

- AM Collins supports a \$25M state litigation fund for immigrations issues, unhoused seniors, DV victims and those facing eviction
- AM Collins supports a \$2.5B fund for LA's wildfire victims, but is meeting with Armon Harvey on 2/20/25 to discuss needs still in San Diego that could be carved out from this fund
- AB 766 indicates that all state departments have to perform a racial impact analysis for any new programs
