# Mayor Todd Gloria Announces New Appointments to City of San Diego's Boards and Commissions

#### 42 APPOINTEES CONFIRMED ACROSS 13 DIFFERENT BOARDS AND COMMISSIONS

SAN DIEGO – Dozens of new and familiar faces are joining the City of San Diego's Boards and Commissions. Following City Council approval, Mayor Todd Gloria recently announced these new appointments and reappointments to serve in key roles on the City's Boards and Commissions. **Eva Friedberg** was appointed to the Historical Resources Board. She serves as President of Evari GIS Consulting. She is qualified as an Architectural Historian by the Secretary of the Interior standards and heads Evari's historic resource consulting arm. Previously, Friedberg served as adjunct faculty at both Woodbury University and the University of San Diego (USD), where she taught courses in architectural history, urban studies and landscape theory. She holds a Bachelor of Arts from the University of California (UC), Berkeley, a Master of Arts and a doctorate degree in visual studies from UC, Irvine. Friedberg is being appointed to a two-year term ending March 1, 2027, in the Architectural Historian Seat. Her appointment replaces Dr. Ann Woods, whose term has expired.

**Dr. Michael Provence**, a professor in the history department at UC San Diego, was appointed to the Historical Resources Board.
